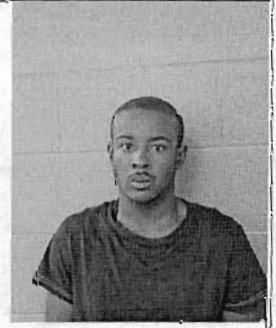

INCIDENT NARRATIVE	<p>(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)</p> <p>EVENT#19612 WHILE A/O'S WERE PLACING A CO ARRESTEE INTO CUSTODY OFFENDER WAS WALKING IN BETWEEN OFFICERS ON SCENE AT WHICH TIME A/O'S ATTEMPTED TO PLACE HIM INTO CUSTODY WHEN HE GRABBED A/O KAHNS LEFT HAND AND TRIED TO PUSH IT AWAY WHILE THROWING A PUNCH WITH HIS LEFT HAND THERE BY PLACING A/O KAHN IN FEAR OF RECEIVING A BATTERY. A/O KAHN DEFENDED HIMSELF BY USING HIS IMPACT WEAPON TO DISABLE THE OFFENDERS DELIVERY SYSTEM. DURING THE DYNAMICS OF THE ALTERCATION THE OFFENDER WAS STRUCK IN THE EAR AREA, AND EMERGENCY TAKE DOWN WAS PERFORMED. IT SHOULD BE NOTED THAT WHILE THE OFFENDER WAS ON THE GROUND HE WAS REACHING FOR AN UNKNOWN OBJECT IN HIS RIGHT POCKET. A/O KAHN RECOVERED A BLACK JACK KNIFE FROM HIS PANTS POCKET. EMERGENCY CUFFING WAS THEN PERFORMED TO PLACE THE OFFENDER INTO CUSTODY AND TRANSPORTED TO 010 DISTRICT FOR PROCESSING.
