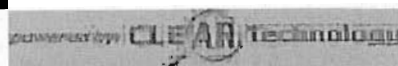

NARRATIVE

EVENT # 19612 IN SUMMARY, R/O'S WHILE ON ROUTINE PARTOL IN AN AREA KNOWN FOR HEAVY GANG AND NARCOTIC ACTIVITY OBSERVED JEROME SIMMONS(OFFENDER) AND LISA SIMMONS(OFFENDER) DRINKING ON THE PUBLIC WAY. R/O'S PLACED THE OFFENDER INTO CUSTODY WITHOUT INCIDENT. WHILE R/O'S WERE PLACING OFFENDERS INTO CUSTODY AN UNRULELY CROWD BEGAN TO FORM AROUND R/O'S AT WHICH TIME R/O'S RADIOED FOR ASSISTANCE. WHILE R/O KAHN #17785 WAS ESCORTING LISA SIMMONS(OFFENDER) TO ANOTHER SQUAD CAR SHE PULLED AWAY MAKEING R/O KAHN BELIEVE SHE WAS ATTEMPTING TO FLEE AT WHICH TIME R/O KAHN RESTRAINED HER AGAINST HIS SQUAD CAR. R/O KAHN AGAIN ATTEMPTED TO ESCORT HER TO ANOTHER SQUAD CAR AND AT THIS TIME OCTAVIUS SIMMONS(OFFENDER) GOT IN THE IMMEDIATE PATH OF P.O. KAHN THEREBY INTERFERING WITH R/O'S OFFICIAL DUTIES. OCTAVIUS SIMMONS(OFFENDER) WAS THEN PLACED INTO CUSTODY FOR SAID CHARGE. WHILE R/O'S WERE PLACING THE OFFENDER INTO CUSTODY HE PULLED AWAY IN AN ATTEMPT TO DEFEAT THE ARREST AND WAS PLACED INTO AN ESCORT HOLD AND EMERGENCY CUFFING PROCEDURES WERE PERFORMED TO AFFECT THE ARREST. DURING ALL OF THE ARRESTS JEREMIAH SMITH(OFFENDER) WAS WALKING IN BETWEEN OFFICERS ON SCENE AT WHICH TIME R/O'S ATTEMPTED TO PLACE HIM INTO CUSTODY WHEN HE GRABBED R/O KAHNS LEFT HAND AND TRIED TO PUSH IT AWAY WHILE THROWING A PUNCH WITH HIS LEFT HAND THERE BY PLACING R/O KAHN IN FEAR OF RECEIVEING A BATTERY. R/O KAHN DEFENDED HIMSELF BY USING HIS IMPACT WEAPON TO DISABLE THE OFFENDERS DELIVERY SYSTEM. DURING THE DYNAMICS OF THE ALTERCATION THE OFFENDER WAS STRUCK IN THE EAR AREA, AND EMERGENCY TAKE DOWN WAS PERFORMED. IT SHOULD BE NOTED THAT WHILE THE OFFENDER WAS ON THE GROUND HE WAS REACHING FOR AN UNKNOWN OBJECT IN HIS RIGHT POCKET. R/O KAHN RECOVERED A BLACK JACK KNIFE FROM HIS PANTS POCKET. EMERGENCY CUFFING WAS THEN PERFORMED TO PLACE THE OFFENDER INTO CUSTODY. WHILE R/O'S WERE LEAVING THE LOCATION TO PROCESS THE OFFENDERS, LUCAS SPICER(OFFENDER) BEGAN TO JUMP IN BETWEEN MARKED SQUAD CARS CAUSING THEM TO ABRUTLY STOP. R/O'S EXITED THEIR VEHICLE TO PLACE THE OFFENDER INTO CUSTODY AT WHICH TIME OFFENDER SPICER BEGAN TO FLEE. R/O'S ENGAGED IN A BRIEF FOOT PURSUIT AND AS OFFENDER SPICER WAS BEING PLACED INTO CUSTODY HE PULLED AWAY AND STIFFENED UP. R/O KAHN WITH THE ASSISTANCE OF UNITS ON SCENE PERFORMED AN EMERGENCY TAKEDOWN WITH HAND CUFFING IN ORDER TO PLACE THE OFFENDER INTO CUSTODY. ALL OFFENDERS TRANSPORTED TO 010 DISTRICT FOR PROCESSING. NAME CHECK CLEAR ON ALL OFFENDERS. FEMALE OFFENDER SEARCHED BY BEAT 1031R, #15419/14796. WHILE PLACING OFFENDERS INTO CUSTODY R/O KAHN SUSTAINED ABRASIONS TO HIS RIGHT ELBOW AND LEFT KNEE AND OFFENDER SMITH SUSTAINED SWELLING AND BRUISING TO THE EAR AREA. ALL INJURIES WERE TREATED BY AMBULANCE #83 WHILE IN THE 010TH DISTRICT STATION.
