INCIDENT NARRATIVE

EVENT #13221 THIS IS AN ARREST BY BEAT 606I. A/OS ON PATROL IN AN UNMARKED VEHICLE, CIVILIAN DRESSED WITH VEST, STAR AND NAME DESIGNATOR IN PLAIN VIEW. IN THAT, A/OS ATTEMPTED TO CURB VEHICLE FOR AN IVC VIOLATION (STOP SIGN), THE VEHICLE REFUSED TO STOP AFTER A/OS ACTIVATED THEIR EMERGENCY LIGHTS/SIREN. VEHICLE DROVE N/B ON EMERALD GOING OPPOSITE DIRECTION ON A ONE WAY STREET. AOS PROCEEDED E/B ON 87TH ST FROM EMERALD WHERE A/OS MANAGED TO OBSERVE THREE OCCUPANTS. THE DRIVER LOOKED AT A/OS DIRECTION AND INTENTIONALLY CRASHED INTO A/OS VEHICLE (633 W.87TH), STRIKING THE FRONT DRIVERS SIDE AREA. A/OS ADVISED THE ZONE OF INCIDENT AND DIRECTION OF FLIGHT. OFFENDING VEHICLE CONTINUED E/B DISOBEYING A SOLID RED SIGNAL AT 8700 SOUTH HOLLAND RD THE OFFENDING VEHICLE THEN DROVE INTO ONCOMING TRAFFIC(87TH ST FROM WENTWORTH-STATE ST.) OFFENDING VEHICLE TURNED LEFT ON TO STATE ST. FROM 87TH ST AND INTENTIONALLY STRUCK A/OS VEHICLE ONCE AGAIN AT THE ENTRANCE OF DAN RYAN EXPRESS WAY RAMP AT 87TH. A/OS FOLLOWED THE VEHICLE ALONG WITH A MARKED VEHICLE (BT.653). THE OFFENDING VEHICLE EXITED THE EXPRESSWAY AT 59TH ST, DROVE W/B ON 59TH ST. AND DROVE TO PEORIA N/B, THEN W/B ON 58TH ST. DISREGARDING NUMEROUS TRAFFIC CONTROLLED DEVICES. OFFENDER CRASHED INTO A MOVING S/B BUS #5031(C.T.A) AT 58TH/RACINE. THE VEHICLE PROCEEDED S/B WITH THE HOOD OF THE VEHICLE EXTENDED IN UPWARD POSITION OBSTRUCTING OFFENDERS VIEW AS THE RESULT OF THE CRASH. THE VEHICLE FINALLY CAME TO STOP AFTER OFFENDER ATTEMPTED TO ENTER THE MOUTH OF THE SOUTH T/ALLEY 58TH PEORIA WHICH WAS OBSTRUCTED BY ONCOMING TRAFFIC FORCING THE OFFENDING VEHICLE TO COME TO AN ABRUPT STOP, CAUSING A/OS VEHICLE TO STRIKE OFFENDING VEHICLE. AFTER OFFENDING VEHICLE CAME TO STOP. A/OS GAVE VERBAL COMMANDS TO STOP AND SURRENDER THEIR HANDS. AFTER A SEVERAL COMMANDS ALL OCCUPANTS OF THE VEHICLE EXITED AND BEGAN TO FLEE. AS THE DRIVER EXITED THE VEHICLE PO. WAGNER GAVE MULTIPLE VERBAL COMMANDS TO STOP AND SHOW PO WAGNER HIS HANDS, AT WHICH TIME OFFENDER/ATWOOD IGNORED THESE COMMANDS AND REACHED INTO HIS WAISTBAND FOR WHICH WAS BELIVED TO BE A HANDGUN. FEARING OFFENDER/ATWOOD WAS ARMED AND CONCEALING A HANDGUN WHILE REACHING FOR WAISTBAND PO. WAGNER DISCHARGED HIS DUTY WEAPON IN FEAR OF HIS LIFE AND LIFE OF HIS PARTNER. AFTER PO WAGNER DISCHARGED HIS DUTY WEAPON THE OFFENDER CONTINUED TO FLEE W/B IGNORING VERBAL COMMANDS TO STOP. PO. WAGNER HOLSTERED HIS WEAPON AND PURSUED THE OFFENDER ON FOOT W/B THROUGH THE ALLEY AND UP ON TO THE RAIL ROAD TRACKS AS HE CONTINUED TO FLEE THROUGH A RESIDENTIAL BACKYARD. OFFENDER/ATWOOD WAS APPRHENDED AT THE ADDRESS OF 5837 S. MORGAN BY BEAT 806C AND PLACED INTO CUSTODY ON SCENE AFTER BEING POSTIVELY IDENTIFIED ON SCENE BY PO. WAGNER AND PO. GARZA. NAME CHECK: DL REVOKED SOS CLEAR NO WANTS NO WARRANTS NO INVESTIGATIVE ALERTS. NO GIPP TRAPP ssl score 218

PO. WAGNER AND PO. GARZA BOTH SUFFERED MINOR INJURY DURING THE TRAFFIC CRASH. (SEE IOD REPORT)
