Brown attempted to flee on foot. Brown was detained in the gangway at the above location. While being detained Brown failed to follow A/O Najm's verbal commands and became an assailant. Brown kicked A/O Najm multiple times about his chest and abdomen. Brown also flailed his arms, stiffened and pulled away in an attempt to defeat the arrest. A/O Najm used reasonable and necessary force to affect the arrest, per the Use of Force Model. A/O Najm sustained minor injuries to his chest and abdomen area. Prior to Brown's arrest, A/O Najm also sustained injuries from being struck by the said Chevy Tahoe, redness, bruising and swelling to A/O's right shoulder, back and right leg.
