INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT#19026 IN SUMMARY, A/O'S RESPONDED TO A CALL OF A PERSON WITH A GUN AT THE AFORMENTIONED ADDRESS. WHEN A/O'S ARRIVED, [REDACTED] SHOUTED, "HE IS IN THE BACK. HE IS TAKING THE GUN IN AND OUT." THE [REDACTED] WERE REFERRING TO THE OFFENDER, NOW KNOWN AS PURNELL, CORNELIUS. AS A/O'S RELOCATED TO THE BACKYARD OF THE RESIDENCE THEY OBSERVED, THE OFFENDER, PURNELL WAS STANDING ABOUT THE ENTRY GARAGE DOOR WITH A HANDGUN IN HIS HAND. A/O'S ANNOUNCED THEIR OFFICE AND ORDERED THE OFFENDER TO DROP HIS WEAPON. AFTER SEVERAL ATTEMPTS, THE OFFENDER DID NOT COMPLY WITH A/O'S COMMANDS. THE OFFENDER, PURNELL RAISED HIS WEAPON IN THE DIRECTION OF A/O'S PERSON. IN FEAR OF RECEIVING A BATTERY, A/O'S DISCHARGED THEIR DUTY WEAPONS STRIKING THE OFFENDER ABOUT THE BODY. THE OFFENDER ATTEMPTED TO DEFEAT THE ARREST BY BRIEFLY FLEEING THE SCENE. ULTIMATLEY HE WAS PLACED IN CUSTODY IN THE BACKYARD AT THE AFOREMENTIONED ADDRESS SUFFERING SEVERAL GUNSHOT WOUNDS ABOUT THE BODY. A/O'S REQUESTED MEDICAL ATTENTION. CONDITION IS UNKNOWN AT THIS TIME BUT TREATED AT CHRIST HOSPITAL. A .45 CAL WAS RECOVERED AND A CUSTODIAL SEARCH OF HIS PERSON REVEALED AN ADDITIONAL HANDGUN, A .380 . PROPER NOTIFICATION WERE MADE TO 006 DISTRICT, WATCH COMMAND, OMEC, 600, 661, 660, AREA 2, OPERATIONS COMMAND, AND ET.
