 EVENT # 17321- IN SUMMARY, LISTED A/O'S WERE ASSIGNED TO GUARD A CRIME SCENE OF A POLICE INVOLVED SHOOTING AT THE ABOVE ADDRESS. SAID CRIME HAD YELLOW CRIME SCENE TAPE THAT WAS LABELED "CRIME SCENE DO NOT CROSS". JASMINE BLACK(OFFENDER) WAS OBSERVED ON THE INSIDE OF TAPED-OFF CRIME SCENE AREA. PO KILMER #5095 STATE OF ILLINOIS (VICTIM AND COMPLAINANT) ORDERED OFFENDER TO LEAVE CRIME SCENE TO WHICH SHE COMPLIED. JASMINE BLACK(OFFENDER) WAS THEN OBSERVED AT THE LISTED ADDRESS WHICH WAS ALSO INSIDE LISTED CRIME SCENE AREA. THERE WAS A LARGE CONGRIGATED CROWD AROUND LISTED CRIME SCENE AND OFFENDER WAS ACTING WITH DISREGARD FOR POLICE AUTHORITY BY SCREAMING "JUST LET ME GO, I DID'T DO SHIT. I DONT CARE ABOUT ALL THIS SHIT, I JUT WANT TO GO HOME" INCITING CROWD TO CONTINUE TO BE UNRULY AND MAKING IT DIFFUCULT FOR OFFICERS TO CONTINUE TO KEEP CROWD CALM. JASMINE BLACK(OFFENDER) WAS PLACED INTO CUSTODY BY SGT MURZYN #1893 AND PO BANSLEY #8791 AFTER BEING REPEATEDLY ORDERED BY PO'S TO LEAVE. OFFENDER WAS THEN TRANSPORTED TO THE 004TH DIST BY BT 465A FOR PROCESSING WHERE SHE WAS SEARCHED BY PO SANDERS #13769 IN THE DIST STATION. JASMINE BLACK(OFFENDER) DEINES GANG AFFILIATION CLEAR GIPP/TRAP, N/C CLEAR. PERSONAL PROPERTY #1289439.
