NARRATIVE

EVENT#16264: IN SUMMARY, WHILE ON PATROL, R/OS OBSERVED MAKAELA THOMAS(OFFENDER) DRIVING LISTED VEHICLE EASTBOUND ON POLK IN VIOLATION OF MCC9-12-050(B). DRIVER THEN PARKED VEHICLE AT APPROXIMATE ADDRESS OF 3417 W POLK AND EXITED VEHICLE FROM DRIVER'S SIDE. R/OS TURNED PATROL VEHICLE AROUND AT INTERSECTION OF POLK AND ST LOUIS AND ATTEMPTED TO STOP DRIVER FOR QUESTIONING REGARDING VIOLATION. AT THIS TIME, R/O FURLET ASKED MAKAELA THOMAS(OFFENDER) TO STOP FOR QUESTIONING. R/OS REPEATEDLY ASKED MAKAELA THOMAS(OFFENDER) FOR HER DRIVER'S LICENSE AT WHICH TIME SHE WAS UNABLE TO PRODUCE IT. MAKAELA THOMAS(OFFENDER) MADE REPEATED ATTEMPTS TO WALK AWAY FROM R/OS STATING, "I'M AT MY HOUSE. I'M AT MY HOUSE. YOU'RE ONLY DOING THIS BECAUSE YOU'RE RACIST." MAKAELA THOMAS(OFFENDER) REMAINED VERBALLY UNCOOPERATIVE AND CONTINUED TO MAKE DEROGATORY COMMENTS REGARDING R/O'S RACE AND SEXUALITY. R/O FURLET WENT TO DETAIN OFFENDER WHO WAS TRYING TO ENTER THE GATE AT LISTED ADDRESS. WHILE ATTEMPTING TO DETAIN OFFENDER, OFFENDER BEGAN TO ATTEMPT TO BREAK AWAY FROM R/O FURLET AND RAISED HER RIGHT ARM WITH A CLOSED FIST AT WHICH POINT R/O FURLET PERFORMED CONTROL HOLDS TO PLACE OFFENDER INTO CUSTODY. R/O JONES SPOKE TO OWNER OF VEHICLE WHO REMAINED IN FRONT PASSENGER SEAT. OWNER OF VEHICLE PROVIDED REGISTRATION TO R/O JONES WHICH WAS CONFIRMED VALID VIA PDT. R/OS WERE THEN ABLE TO OBTAIN DRIVER'S LICENSE OF OFFENDER. NAME CHECK VIA PDT REVEALED DRIVER'S LICENSE SUSPENDED. BT 1110 ON SCENE AT THIS TIME. OFFENDER PLACED INTO CUSTODY FOR 625ILCS5/6303(A) AND TRANSPORTED TO 011 DISTRICT FOR FURTHER PROCESSING. R/OS BECAME AWARE THAT OFFENDER WAS ABLE TO REMOVE LEFT HAND OUT OF DOUBLE LOCKED HANDCUFFS. PRIOR TO ARRIVING AT 011 DISTRICT, R/OS REQUESTED ASSISTANCE FROM ADDITIONAL UNIT WITH FEMALE OFFICER. BT 1131 MET R/OS AT 011 DISTRICT TO ASSIST WITH PLACING OFFENDER INTO LOCKUP. P.O. BARRIOS #5795 OF BT 1131 ASSISTED P.O. HOWARD #10944 OF 011 FEMALE LOCK UP AS OFFENDER REMAINED AGGRESSIVE. P.O. BARRIOS ENTERED CELL BLOCK A-3 TO ASSIST P.O. HOWARD#10944 WITH CUSTODIAL SEARCH. P.O. HOWARD REMOVED OFFENDER'S RIGHT SHOE IN ORDER TO TAKE OFF SHOE LACE AT WHICH TIME OFFENDER PROCEEDED TO TRY TO KICK P.O. BARRIOS #5795 WITH HER LEFT FOOT, CAUSING OFFENDER TO SLIP AND FALL TO THE CELL BENCH CAUSING A SMALL LACERATION TO HER CHIN. OFFENDER TRANSPORTED TO ST. ANTHONY HOSPITAL FOR TREATMENT BY BT 1171R.
