IN SUMMARY: ON 08.09.2015 AT APPROXIMATELY 0334 HRS, RESPONDING OFFICER C. WRIGHT #584 (R/O) RESPONDED TO THE JUSTICE SOCIAL CLUB LOCATED AT 2829 W. 167th STREET IN REFERENCE TO AN UNWANTED SUBJECT(S) COMPLAINT.

WHILE IN ROUTE TO THE LOCATION R/O WAS INFORMED VIA MARKHAM DISPATCH THAT SHOTS HAD BEEN FIRED AT THE SOCIAL CLUB. R/O WAS FIRST ON SCENE AND IMMEDIATELY BLOCKED THE EAST PARKING LOT EXIT. R/O INFORMED RESPONDING MARKHAM UNITS TO BLOCK THE WEST PARKING LOT EXIT. UPON ARRIVAL R/O SPOKE WITH OFF-DUTY CHICAGO POLICE OFFICER MARCUS WADE IN REFERENCE TO THIS INCIDENT. OFFICER WADE INFORMED R/O THAT THERE WAS A GROUP OF M/B'S OF WHICH AT LEAST ONE SUBJECT FIRED MULTIPLE SHOTS.

OFFICER WADE INFORMED R/O THAT THE SUSPECTS WERE AT THE REAR OF THE SOCIAL CLUB AND THAT HE RETURNED FIRE AT THE SUBJECTS. R/O OBSERVED THE SUSPECTS ON THE WEST SIDE OF THE SOCIAL CLUB PARKING LOT ON THE RIGHT SIDE. R/O INSTRUCTED THE SUSPECTS TO PUT THEIR HANDS UP AND COME OUT FROM BEHIND THE PARKED VEHICLES. THE SUSPECTS DID NOT COMPLY. OFFICER WADE FOLLOWED R/O IN PURSUIT OF THE SUSPECTS. ONCE R/O REACHED THE MIDDLE OF THE PARKING LOT R/O COULD SEE THE SUSPECTS MOVING BEHIND THE PARKED VEHICLES. AGAIN, R/O INSTRUCTED THE SUSPECTS TO "COME FROM BEHIND THE VEHICLES WITH YOUR HANDS ABOVE YOUR HEADS!" AGAIN, THE SUSPECTS DID NOT COMPLY. R/O TOOK A DEFENSIVE POSITION 4 - 5 CARS BEHIND THE SUSPECTS ON THE LEFT SIDE OF THE PARKING LOT. R/O WAS READY TO APPROACH THE LEFT FLANK OF THE SUSPECTS WHEN R/O NOTICED THAT OFFICER WADE WAS ENGAGED IN AN PHYSICAL ALTERCATION WITH AN UNKNOWN M/B. OFFICER WADE DETAINED 2 - 3 MALE BLACKS (M/B'S) IN THE COURSE OF THIS ACTION.

NARRATIVE SUPPLEMENT

R/O REQUESTED RESPONDING UNITS TO EXPEDITE TO THE REAR OF THE CLUB. R/O WAS JOINED BY OFFICER ANDERL #585. R/O AND OFFICER ANDERL CONTINUED PURSUIT OF THE SUSPECTS. AT THIS POINT THE SUSPECTS WERE NO LONGER BEHIND THE PARKED VEHICLES. THE OFFENDERS RAN INTO AN OPEN FIELD BEHIND THE JUSTICE SOCIAL CLUB. R/O OBSERVED SGT D. WALKER FROM HIS VEHICLE COMMANDING A SUBJECT TO KEEP HIS HANDS UP AND GO DOWN TO THE GROUND. THE SUBJECT HAD HIS HANDS IN THE AIR, BUT DID NOT GO TO THE GROUND. R/O AND OFFICER ANDERL ASSISTED THE SUSPECT TO THE GROUND AND DETAINED HIM WITH HANDCUFFS. R/O, OFFICER ANDERL AND OFFICER B. JACKSON SEARCHED THE AREA WHERE THE SUSPECT WAS DETAINED, BUT WAS UNSUCCESSFUL IN FINDING ADDITIONAL SUBJECTS.

R/O WAS INSTRUCTED VIA SGT. D. WALKER TO RELOCATE TO CHRIST HOSPITAL TO INTERVIEW THE GUN SHOT VICTIM [REDACTED]. ONCE ON SCENE R/O OBSERVED A GUN SHOT WOUND (GSW) TO THE LOWER LEFT LEG (SHIN) OF THE VICTIM. R/O WAS INFORMED THAT THE VICTIM WAS IN STABLE CONDITION. THE VICTIM WAS ABLE TO GIVE R/O THE FOLLOWING INFORMATION.

[REDACTED] STATED THAT NEITHER HE OR HIS CREW KNOWN AS TRUE BELIEVERS ENTERTAINMENT (T.B.E.) WERE INVOLVED IN ANY ALTERCATION INSIDE THE CLUB. THE VICTIM FURTHER STATED THAT AT NO POINT DID HE OR ANY MEMBER OF HIS CREW ARGUE WITH ANYONE INSIDE OR OUTSIDE OF THE SOCIAL CLUB.

[REDACTED] FURTHER STATED THAT HE LEFT OUT OF THE CLUB TO CHECK ON HIS WIFE [REDACTED]

[REDACTED] STATED THAT ONCE HE WALKED OUT OF THE CLUB HE WAS IMMEDIATELY ATTACKED BY MULTIPLE UNKNOWN SUBJECTS. THE VICTIM ADVISED THAT HE WAS ABLE TO GET AWAY, HOWEVER MOMENTS LATER HE HEARD MULTIPLE GUNSHOTS. [REDACTED] RELATED THAT HE DIDN'T REALIZE THAT HE HAD BEEN STRUCK UNTIL UNKNOWN BYSTANDERS TOLD HIM TO GET DOWN ON GROUND. [REDACTED] WAS ADVISED THAT THE BYSTANDERS TRIED TO HELP HIM AND IN FACT INFORMED HIM THAT HE HAD BEEN SHOT AND TO STAY DOWN. [REDACTED] STATED THAT HE DID NOT RECALL THE SHOOTER, HOWEVER HE REMEMBERS SEEING A BLACK GUN. [REDACTED] FURTHER ADVISED THAT HE DID NOT GET A GOOD LOOK AT THE OFFENDERS WHEN THEY WERE ATTACKING HIM.

R/O WAS ADVISED BY THE VICTIM'S WIFE THAT SHE HAD AT LEAST TWO FEMALE FRIENDS WHO WERE OUTSIDE OF THE CLUB IN THE AREA OF THE SHOOTING. R/O SPOKE WITH [REDACTED] ABOUT THE INCIDENT AND WAS INFORMED THAT SHE HEARD MULTIPLE GUNSHOTS. MS. [REDACTED] COULD NOT RECALL HOW MANY SHOTS SHE HEARD. MS. [REDACTED] RELATED THAT THE OFFENDERS WERE TRYING TO PAY PEOPLE FOR A RIDE OUT OF THE PARKING LOT. MS. [REDACTED] RELATED THAT ONE OF THE M/B'S WAS PULLING ON CAR DOORS AND IN FACT TRIED TO ENTER HER VEHICLE. MS. [REDACTED] ADVISED THAT SHE COULD POSSIBLY IDENTIFY THE M/B WHO TRIED TO ENTER HER VEHICLE. MS. [REDACTED] RELATED THAT SHE HEARD ONE OF THE SUBJECTS INSTRUCT ANOTHER SUBJECT TO "GET RID OF YOUR JACKET!"

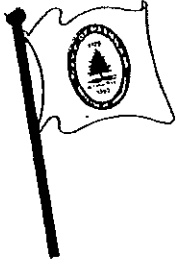
