INCIDENT NARRATIVE
<p>(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)</p> <p>event #13516 address of arrest 6120 s. eberhart chicago, il cook county</p> <p>R/O's with prior knowledge of narcotics sales in the area set up a point of surveillance in the area of 6120 s. Eberhart Chicago. R/o observed offender Mosley walk up to the porch located at 6120 s. Eberhart and then tender paper u.s.c. to an unknown male/black on the porch. The unknown male/black then accepted the paper u.s.c and then tendered a small item which R/O recognized to be narcotics to Mosley. R/o's believing they just witnessed a narcotic's transaction broke surveillance, radioed enforcement officers and approached 6120 s. Eberhart. R/O's approached the unknown male/black that had tendered the suspect narcotics to Mosley at which point he fled into 6120 S. Eberhart and was not located; made good on his escape. Offender Mosley was immediately detained, PO Homer observed in offender Mosley's left hand (1) zip lock bag containing suspect heroin. PO Homer ordered offender Mosley to open his hand. Mosley refused and then turned towards PO Homer lowered his head and shoulder and forcefully pushed/charged into PO Homer while trying to make his escape. Mosley began to state, "You are going to have to shoot and kill me." P.O. Homer then used an emergency take down to effectively control offender Mosley, while using verbal commands in order to obtain compliance. PO Babicz then immediately recovered from Mosley's left hand (1) zip lock bag containing suspect heroin. Mosley sustained a laceration above his left eye during the emergency take down and was transported immediately to Mercy Hospital. While en route to the hospital R/O's could detect a strong odor coming from offender's breath. While at Mercy Hospital Mosley refused medical treatment and refused to sign the medical treatment refusal form. Mosley refused to let the hospital staff clean his laceration or apply a bandage. At the hospital Mosley stated, "Fuck all white people&#8230;I do I not want to talk to or get help from a white doctor." Offender was then transported to central detention for processing. Name check of offender revealed three active warrants that are not serviceable. Offender is clear g.i.p.p. and t.r.a.p. No two degrees. TRR completed.</p>
