NARRATIVE

EVENT #00985IN SUMMARY WHILE ON PATROL, R/O WAS FLAGGED DOWN BY A [REDACTED] (VICTIM AND COMPLAINANT) A CAB DRIVER THAT STATED A UNKNOWN OFFENDER EXITED HIS CAB WITHOUT PAYING THE CAB FEE OF \$22.65 U.S.C. R/O ASKED DRIVER TO DESCRIBE THE OFFENDER AND THE DIRECTION OF TRAVEL. DRIVER STATED THE OFFENDER APPEARANCE WAS OF A MIXED ETHNICITY, SIX FEET TALL AND HE PULLED A GREY HOODIE OVER HIS HEAD AS HE EXITED THE CAB AND THE OFFENDER ENTERED ONE SIDE OF THE BANK PARKING LOT ON MADISON AVE AND EXITED ON RACINE AVE IN AN ATTEMPT TO FLEE. R/O DROVE THRU THE BANK LOT, UPON EXTING R/O OBSERVED UNKNOWN SUBJECT FITTING THE CLOTHING DESCRIPTION OF OFFENDER. R/O PULLED ALONG SIDE OF OFFENDER AND ASKED OFFENDER TO STOP WALKING AND REMOVE BOTH HIS HANDS FROM THE POCKET OF HIS HOODIE, OFFENDER YELLED "FOR WHAT AND WHAT THE FUCK DO YOU WANT WITH ME" AT WHICH TIME R/O CLEARLY OBSERVED THAT OFFENDER MATCH THE DESCRIPTION THAT WAS GIVEN BY [REDACTED] (VICTIM AND COMPLAINANT) AGAIN R/O ASKED OFFENDER TO STOP WALKING AWAY FROM R/O, OFFENDER AGAIN YELLED "WHAT THE FUCK DO YOU WANT" AND "WHAT DID I DO" R/O WAS ABLE TO STOP OFFENDER WHOM CONTINUED TO REFUSE TO REMOVE BOTH HANDS FROM HIS HOODIE POCKET; OFFENDER SIMULTANEOUSLY BEGAN JERKING HIS BODY AWAY R/O AND PULLED BOTH HANDS FROM HIS HOODIE ABOVE R/O'S HEAD, AT WHICH TIME R/O USED A TAKEDOWN TO SUBDUE OFFENDER MOMENTARILY, OFFENDER CONTINUED TO LOCK HIS WRIST AND ARMS TO PREVENT R/O FROM PLACING OFFENDER INTO CUSTODY AFTER HAVING BEEN ORDERED SEVERAL TIMES TO UNLOCK HIS ARMS. R/O WAS ABLE TO PLACE CUFFS ON SUBJECT AFTER SGT. SCHWIEGER #921 AND OTHER OFFICERS ASSISTED. RECEIPT INVENTORY #13429156 ARRESTEE REFUSED MEDICAL ATTENTION FROM AMD #28
