INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT# 00168, THIS IS AN ARREST BY GANG ENFORCEMENT UNITS 6753/6751/6750. IN SUMMARY A/O'S RECIEVED INFORMATION THAT A HEAVY SET F/1 WOULD BE DELIVERING A LARGE QUANTITY OF ECSTACY PILLS TO THE PARKING LOT LOCATED AT 111 N KEDZIE IN A NEWER MODEL BLACK CHEVY MALIBU. A/O'S SET UP SURVEILLANCE WHERE THEY OBSERVED A VEHICLE MATCHING THE DESCRIPTION PARK IN THE PARKING LOT WHERE ALL OCCUPANTS WAITED INSIDE THE VEHICLE. OFFENDER WAS THE DRIVER OF THE VEHICLE. A/O'S ENTERED THE PARKING LOT IN THEIR SQUAD CARS WHERE THE CO-ARRESTEE (NEIL, Jermeka), THE PASSENGER OF THE VEHICLE, GRABBED THE STEERING WHEEL AND THE VEHICLE ACCELERATED STRIKING SGT. RENTER'S #2052 VEHICLE AND FLED N/B ON KEDZIE. UPON CURBING THE AT ABOVE ADDRESS VEHICLE IT WAS DISCOVERED OFFENDER COULD NOT PRODUCE HIS DRIVERS LICENSE OR PROOF OF INSURANCE AND AN UNRESTRAINED CHILD [REDACTED] IN THE BACK SEAT. OFFENDER AND CO-ARRESTEE WERE PLACED INTO CUSTODY. P.O. KROLL #14373, A PASSENGER IN THE VEHICLE STRUCK, SUSTAINED INJURIES TO HIS LEFT HAND, LOWER BACK AND RIGHT SHOULDER. SGT RENTNER #2052 SUSTAINED INJURIES TO HIS NECK AND RIBS. OFFENDER STATED POST MIRANDA IN ESSENCE THAT WHEN THE POLICE ARRIVED IN THE PARKING THE CO-ARRESTEE YELLED FOR HIM TO LEAVE, GRABBED THE STEERING WHEEL AND FORCED DOWN ON THE GAS PEDAL. OFFENDER STATED THAT HE FOUGHT WITH CO-ARRESTEE THE ENTIRE WAY AND WAS FINALLY ABLE TO STOP THE CAR AT HURON/KEDZIE. OFFENDER HAS NO ID, NO USC, NAME CHECK CLEAR VIA LEADS/DATAWAREHOUSE, GIPP CLEAR.
