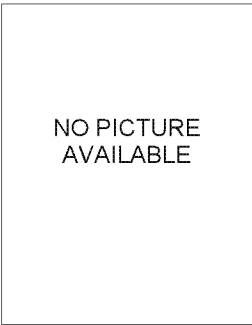

EVENT #18736 Subject Omar Young was placed into custody after he was identified as one of three offenders who robbed the B & B Beauty Supply Store while armed with a handgun. After the robbery Young fled and pointed the handgun in the direction of the A/Os. The officers in fear for their lives fired their weapons at YOUNG after he refused verbal commands to stop and drop the gun. Young was subsequently shot and placed into custody. YOUNG was transported to MT SINAI for treatment.
