A/O'S SURROUNDED THE PERIMETER, AT WHICH POINT ABOVE OFFENDERS STOLE ABOVE VEHICLE, AND DROVE VEHICLE THROUGH GARAGE DOOR TO DEFEAT ARREST STRIKING P.O. PAPIN #3020 CAUSING HIM TO GO TO THE GROUND.
