A/O'S RESPONDED TO A BURGLARY IN PROGRESS AT 2459 S. WESTERN AVE. ONCE ON SCENE, A/O'S OBSERVED OFFENDERS INSIDE THE BUILDING LOADING ITEMS INTO VICTIMS VEHICLE WHICH WAS PARKED INSIDE THE ESTABLISHMENT. A/O'S SURROUNDED THE PERIMETER, AT WHICH POINT ABOVE OFFENDER'S STOLE ABOVE VEHICLE, AND DROVE VEHICLE THROUGH GARAGE DOOR TO DEFEAT ARREST STRIKING P.O. PAPIN #3020 CAUSING HIM TO GO TO THE GROUND. DURING THE COURSE OF PLACING OFFENDERS INTO CUSTODY, ABOVE OFFENDER AND CO-OFFENDER DUDLEY, LELAND WERE SHOT BY POLICE, AND CO-OFFENDER STRONG, DAVID WAS SHOT AND KILLED BY POLICE.
