CONTINUATION OF NARRATIVE AGGRAVATED BATTERY

(LANGE) WAS INVOLVED IN A TRAFFIC ACCIDENT AT [REDACTED] WITH THE MOTORCYCLE COMING TO REST IN FRONT OF 1107 S. 1ST AVE. A FIGHT ENSUED WHEN OFFENDER #1 (MIDDLETON, CHRISTOPHER) AND OFFENDER #2 (PASSEY, JOHN D. OF [REDACTED] M/B DOB [REDACTED]) ATTACKES THE VICTIM, STRIKING THE VICTIM WHILE THE VICTIM WAS ON HIS BACK. THE VICTIM (AN OFF DUTY PEACE OFFICER) UNHOLSTERED HIS FIREARM (WEAPON) AND DISCHARGED HIS WEAPON, STRIKING OFFENDER #1 (MIDDLETON) IN THE LOWER ABDOMEN/GROIN AREA.
