AT 242 W 110TH PL IN THE BACK YARD, OFFENDER REMOVED A CHROME HANDGUN AND POINTED THE WEAPON AT A/O SKARUPINSKI #8254. A/O SKARUPINSKI #8254 IN FEAR OF HIS LIFE FIRED HIS WEAPON ONE TIME TOWARDS THE OFFENDER, BUT DID NOT STRIKE THE OFFENDER.
