

AREA CENTRAL DETECTIVES WHERE CONDUCTING A ROBBERY INVESTIGATION AND SURVEILLANCE WHEN BEAT 5105 LT. O. VALDEZ #529 OBSERVED HASAN, SADAT ENTER AND LEAVE A RESIDENCE WITH POSSIBLE PROCEEDS FROM A ROBBERY, THEN ENTER A BLACK GMC SUV, LT. VALDEZ RELATED VIA RADIO TO STOP THE VEHICLE. BEAT 5108 DET. E. CHOPP AND DET. M. WALSH OBSERVED AND FOLLOWED THE VEHICLE IN A COVERT CAR AT WHICH TIME DET. M. FILBIN AND DET. M. HENNELLY DRIVING A UNMARKED SQUAD EQUIPPED WITH EMERGENCY EQUIPMENT CURBED THE VEHICLE. DURING THE COURSE OF THE TRAFFIC STOP DET. CHOPP OBSERVED THRU THE WINDOW IN PLAIN VIEW A GLASS CONTAINER OF SUSPECT CANNABIS IN THE PASSENGER AREA OF THE VEHICLE. HASAN WAS PLACED UNDER ARREST FOR POSSESSION OF SUSPECT CANABIS INV# 12859431 . FURTHER INVESTIGATION REVEALED A BAG OF CELL PHONES SUSPECT ROBBERY PROCEEDS INV# 12859444 & INV# 12859446. LT. VALDEZ POSITIVELY IDENTIFIED HASAN AS THE SUBJECT HE OBSERVED LEAVING THE RESIDENCE WITH POSSIBLE ROBBERY PROCEEDS.
