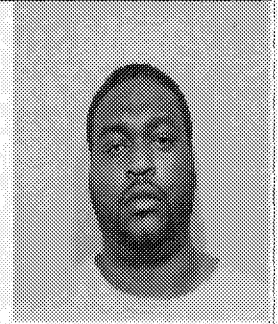

INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT#17321, IN SUMMARY, A/O'S WERE RESPONDING TO A CALL OF 10-1, SHOTS FIRED AT 8850 S. BURLEY AVE. UPON ARRIVAL A/O WAKE OBSERVED ABOVE ASSAILANT/ARRESTEE(BOOTH, WILLIE) ENGAGING POLICE OFFICERS ON SCENE IN AN AGGRESSIVE MANNER. WHILE POLICE OFFICERS WERE SECURING A CRIME SCENE CLEARLY IDENTIFIABLE THROUGH WEARING UNIFORMS AND OUTER VESTS WITH THE WORDS "CHICAGO POLICE". ABOVE ASSAILANT(BOOTH, WILLIE) IGNORED SEVERAL VERBAL COMMANDS FROM SGT. MATA TO DESPURSE FROM THE CRIME SCENE. ABOVE ASSAILANT APPROACHED SGT. MATA IN AN AGGRESSIVE MANNER, IN A BLADED STANCE WITH CLINCHED FISTS, AND CURSING. SGT. MATA FEARING HE WAS ABOUT TO BE THE VICTIM OF A BATTERY, DEPLOYED O.C. SPRAY AT ABOVE ASSAILANT, SPRAYING HIM IN THE FACE AND HEAD AREA. ABOVE OFFENDER TURNED AND STARTED TO FLEE. A.O. WAKE GAVE CHASE AND PERFORMED AN EMERGENCY TAKEDOWN AND CUFFING AT THE ADDRESS OF ARREST. IN THE COURSE OF THE TAKEDOWN AND CUFFING, P.O. WAKE SUFFERED AND INJURY TO THE BACK OF HIS RIGHT CALF, RESULTING IN BRUISING AND SWELLING. ABOVE OFFENDER WAS THEN TRANSPORTED TO 004TH DISTRICT FOR PROCESSING, AND WHERE HE RECEIVED WATER TO FLUSH OUT THE O.C. SPRAY FROM HIS FACE. OFFENDER READ RIGHTS PER MIRANDA. WHILE AT 004TH DISTRICT ABOVE OFFENDER WAS APOLOGISING FOR COMING AGGRESSIVELY AT OFFICERS, STATING THAT IT WAS [REDACTED] THAT WAS SHOT AND HE WAS VERY UPSET. N.C.C., NO WARRANTS/ALERTS, NOT ON GIPP/TRAP PROGRAMS, NOT ON PAROLE/PROBATION, ABOVE OFFENDER IS A SELF ADMITTED GANGSTER DISCIPLE. OFFENDER HAS \$75.00 USC ON HIS PERSON.
