(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT # 17321. THIS IS AN ON-VIEW ARREST BY THE 004 DISTRICT TACTICAL TEAM. IN SUMMARY, THE 463 TACTICAL TEAM WAS WOLF PACKING IN THE VICINITY OF 88TH AND BURLEY FOR A VIOLENCE SUPPRESSION DUE TO THE RECENT HOMICIDE OF KEVIN SANDERS IR#1168955 UNDER RD# HW230759. AT SAID TIME 463C OBSERVED A LARGE CROWD AT THE LOCATION OF 8806 S. BURLEY. A/O'S ATTEMPTED TO CONDUCT A FIELD INTERVIEW WITH THE OFFENDER NOW KNOWN AS (GLAZE, ORTIZ) WHO WAS OBSERVED DRINKING WHAT APPEARED TO BE AN ALCOHOLIC BEVERAGE. UPON APPROACH, OFFENDER MADE FURTIVE MOVEMENT UNDER A PARKED VEHICLE AND TOWARD HIS WAISTBAND WHICH A/O'S BELIEVED TO BE CONCEALING A WEAPON. A/O'S ORDERED OFFENDER TO PRODUCE HIS HANDS AND STOP AT WHICH TIME HE FLED GRASPING AT HIS WAIST WITH HIS RIGHT HAND. A/O JONES GAVE CHASE ON FOOT WITH A/O GARCIA FOLLOWING IN VEHICLE AT WHICH TIME A/O JONES OBSERVED THE OFFENDER PRODUCE A CHROME OBJECT FROM HIS WAISTBAND WHICH HE BELIEVED WAS TO BE A HANDGUN AND IN FEAR OF HIS LIFE AND HIS PARTNER LIFE DISCHARGED HIS WEAPON STRIKING THE OFFENDER. A/O GARCIA UPON HEARING THE SHOTS AND SEEING OFFENDER MAKING FURTIVE MOVEMENT TOWARD PO JONES AND IN FEAR OF HIS PARTNERS LIFE AND HIS OWN ALSO DISCHARGED HIS WEAPON. SUBJECT PLACED INTO CUSTODY AND A/O'S IMMEDIATELY CALLED FOR MEDICAL ATTENTION (AMBULANCE) VIA OEMC. OFFENDER TAKEN TO STROGER HOSPITAL BY AMBULANCE # 9 IN STABLE CONDITION. NOT ON G.I.P.P. NOT ON T.R.A.P. INVESTIGATIVE ALERT # 299975950 NO PROBABLE CAUSE TO ARREST DET A/SOUTH. NAME CHECK CLEAR NO RECORD.
