NARRATIVE

EVENT # 17321- IN SUMMARY, LISTED A/O'S WERE ASSIGNED TO GUARD A CRIME SCENE OF A POLICE INVOLVED SHOOTING AT THE ABOVE ADDRESS. SAID CRIME HAD YELLOW CRIME SCENE TAPE THAT WAS LABELED "CRIME SCENE DO NOT CROSS". JASMINE BLACK(OFFENDER) WAS OBSERVED ON THE INSIDE OF TAPED-OFF CRIME SCENE AREA. PO KILMER #5095 STATE OF ILLINOIS (VICTIM AND COMPLAINANT) ORDERED OFFENDER TO LEAVE CRIME SCENE TO WHICH SHE COMPLIED. JASMINE BLACK(OFFENDER) WAS THEN OBSERVED AT THE LISTED ADDRESS WHICH WAS ALSO INSIDE LISTED CRIME SCENE AREA. THERE WAS A LARGE CONGRIGATED CROWD AROUND LISTED CRIME SCENE AND OFFENDER WAS ACTING WITH DISREGARD FOR POLICE AUTHORITY INCITING CROWD TO CONTINUE TO BE UNRULY.
