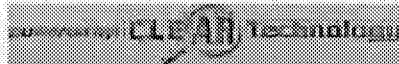

NARRATIVE

EVENT # 16078. THIS IS AN ARREST BY THE 004 DISTRICT TACTICAL TEAM 463A. IN SUMMARY, A/OS RESPONDED TO A 10-1 EMERGENCY CALL (EVENT # 17321). UPON ARRIVAL ABOVE SUBJECT REFUSED TO COOPERATE WITH OFFICERS REPEATED ORDERS TO MOVE BEHIND THE CRIME SCENE TAPE AS OFFICERS ON SCENE WERE ATTEMPTING TO GET MEDICAL ATTENTION TO SUBJECT THAT WAS SHOT. SUBJECT KEPT USING PROFANITY AND BERATED OFFICERS BY STATING "FUCK YOU I DONT HAVE TO MOVE" AND "FUCK YOU!" AND CONTINUED TO INCITE THE CROWD THAT HAD NOW BECOME HOSTILE TOWARDS OFFICERS. SUBJECT RECEIVED MULTIPLE ORDERS TO MOVE BACK AND BEHIND THE CRIME SCENE TAPE AND SUBJECT SAID "NO". AFTER NUMEROUS WARNINGS SUBJECT CONTINUED INTERFERENCE WITH OFFICERS CONTROLLING THE SCENE AND GETTING MEDICAL PERSONNEL TO RENDER AID TO OFFENDER SHOT. SUBJECT ACTIONS OF INCITING A HOSTILE CROWD AND MAKING DIFFICULT FOR OFFICERS TO ALLOW MEDICAL PERSONNEL INTO CRIME SCENE PLACED OFFICERS AND OFFENDER SHOT IN FURTHER DANGER. SUBJECT WAS PLACED INTO CUSTODY, TRANSPORTED TO 004 FOR PROCESSING AND CHARGED ACCORDINGLY. AT 004 DISTRICT POLICE STATION SUBJECT CONTINUED TO "YELL FUCK YOU I'M GOING TO SUE YOU." "HOW THE FUCK YOU GOING YOU GOING TO GET ME ARRESTED" NOT ON GIPP NOT ON TRAP NO INVESTIGATIVE ALERTS NAME CHECK CLEAR. NOT ON PAROLE.
