



BARBER, S. 12220 (COMPLAINANT) IN A MENACING MANNER LEAVING THE SIDEWALK FROM IN FRONT [REDACTED] ENTERING THE STREET WHERE OFC. BARBER, S. 12220 (COMPLAINANT) WAS ATTEMPTING TO SEARCH FOR OFFENDERS WHO HAD FIRED SHOTS STATING "I WILL FUCKING SHOOT YOU." "I WILL FUCKING SHOOT THE POLICE." IVAN RUSSELL (OFFENDER) THEN STATED "AINT SHIT GOING ON OVER HERE." WHAT THE FUCK Y'ALL DOING." "WHAT THE FUCK Y'ALL LOOKING FOR." THE ABOVE ACTIONS OF IVAN RUSSELL (OFFENDER) PLACED OFC. BARBER, S. 12220 (VICTIM AND COMPLAINANT) AND OFC. CORNELL, V. #7184 (VICTIM AND COMPLAINANT) IN FEAR OF BODILY HARM AND RECIEVING A BATTERY, THERE BY, WHICH IVAN RUSSELL (OFFENDER) COMMITTED THE CRIMINAL OFFENSE OF AGGRAVATED ASSAULT TO POLICE OFFICER AND RECKLESS CONDUCT IN THAT THE ACTIONS OF IVAN RUSSELL (OFFENDER) IMPEDED AND DELAYED THE OFFICERS INVESTIGATION THERE BY, PLACING OTHERS IN HARMS WAY IN A RESIDENTIAL AREA OF WHICH SHOTS WERE FIRED.
