INCIDENT NARRATIVE

EVENT #1317700123

In summary: While investigating a Police involved shooting, Reporting Detective's Dineen #20756 & Kalicki #20969 learned that a male black offender had exchanged gunfire with a Police Officer and may had been injured as a result of this incident. It was presumed that the offender was injured based on the blood splatter that was found in the area of this incident. While searching this area Detective's Dineen and Kalicki observed blood on the door of a locked shed in the rear of [REDACTED]. Further investigation revealed that the shed's door was normally kept unlocked. After gaining permission from the resident of this location to enter the shed, the R/D's gained entry and discovered the offender WALLACE hiding inside and he was then detained by the R/D's. An on-scene show up was then conducted and the offender WALLACE was positively identified by the Police Officers / victim's involved in this incident. The offender WALLACE was then placed in custody. It should be noted that WALLACE was found to have an apparent gunshot wound to his left hand. Due to his injury WALLACE was transported to Little Company of Mary Hospital by CFD ambulance #29. WALLACE was accompanied to the hospital by Beat 2261D. At Little Company of Mary Hospital the offender WALLACE was treated by Dr [REDACTED] who listed the offender in stable condition. Thru CPD resources the offender WALLACE was found to be associated with the Killer Ward Gangster Disciples. Name check clear, no investigative alerts; not on GIPP / TRAPP; no inventories and no USC on his person.
