IN SUMMARY: R/S AND PO MCCABE RESPONDED TO A OEMC CALL OF A SUBJECT ATTEMPTING SUICIDE. UPON ARRIVAL, THE SUBJECT WAS NOT ON THE SCENE. R/S SPOKE WITH [REDACTED] IN ATTEMPT TO LEARN IF THE SUBJECT HAD A GUN AND WHAT HIS LOCATION WAS. [REDACTED] RELATED THAT HE OWNED A GUN AND WENT TO LOOK FOR IT WITH R/S, PO MCCABE, AND SGT SIMON. [REDACTED] THEN LOCATED A GREEN CAMOUFLAGE BAG IN [REDACTED] BEDROOM CLOSET WHICH CONTAINED 8 BOXES OF AMMUNITION(50 ROUNDS EACH) AND ONE BOX OF AMMUNITION(100 ROUNDS) ALL OF WHICH WERE 9MM. THE BAG ALSO CONTAINED A GUN, CLEANING KIT AND HOLSTER AND TWO 9MM MAGAZINES AND ONE LEATHER MAN TYPE TOOL AND A MEDALLION. [REDACTED] ALSO LOCATED A GLOCK GUN BOX UNDER A BEDSIDE TABLE WHICH CONTAINED A 9MM GLOCK SEMI AUTO BLUE STEEL G17 GEN4 SER#RSU889 HANDGUN WHICH WAS SECURED WITH A LOCK AND ONE MAGAZINE. ALSO RECOVERED IN THE BEDROOM WAS A MARKMAN .177 BB GUN. [REDACTED] STATED THAT [REDACTED] R/O'S THEN INVENTORIED ALL ITEMS IN THE 022 DISTRICT. WEAPON CLEAR NOT REGISTERED PER GUN DESK LANE #340.
