INTERVIEWED:

INVESTIGATION:

The Reporting Detectives (R/D's) were assigned to the police involved shooting at 10931 S. Eberhart by Sgt. Blas #1248 of this command. The R/Ds once on the scene observed the scene to be located in a residential area.

The R/Ds noted that yellow crime scene tape was placed at the north end of Eberhart Street at 10900 across to 10901 S. Eberhart. The R/Ds walked to 10931 S Eberhart taking note that the inner crime scene area was also cordoned off from 10926 across to 10929 on the north end and from 10934 across to 10935 S Eberhart.

The R/Ds noted that the residence is a two flat that is utilized as single family dwelling, as all interior doors are left ajar.

A C.F.D. Ambulance was summoned via police radio zone number nine. C.F.D. Ambulance number 29 arrived and transported Ms. Angelique Styles to Advocate Christ Hospital, in Oak Lawn, IL.

The R/Ds learned from Detectives Brian Drees #20522 and David Garcia #20429 that they met with Lieutenant Michael Casey #191, Beat 599. The Lt. related the following in summary and not word for word.

Lt. Casey related that he spoke with [REDACTED] [REDACTED] [REDACTED] at the scene, after the incident.

(See Canvass supplementary report for interview of Reverend Clifford Spears)

The R/Ds conducted separate walk throughs with each officer involved in this incident.

Beat 5802 F/I P. PRESNELL #17122 arrived to process the scene. The R/Ds, along with detectives Madden, McGuire and Pullappally, conducted a survey of the scene, noting items of evidentiary value and informing the F/I of same. The F/I collected, Photographed and inventoried all recovered items in this matter. (See separate crime scene report)

NARRATIVES

The Reporting Detective interviewed officers Cavanaugh and Murrah separately regarding the shooting incident that occurred at 10931 S Eberhart. The following statements are in essence and not verbatim.

Officer Ronald Cavanaugh #3274

Cavanaugh related that he was assigned to beat 571 Wagon/Van on today's date 24 Oct 2013, along with partner, Officer Christopher Murrah #18003 in full uniform. The R/D inquired if Cavanaugh was taser trained and currently qualified. Cavanaugh related that he is not trained nor qualified to carry a department issued taser.

The R/D asked if the vehicle that Cavanaugh was assigned to on 24 Oct 2013 was equipped with an in car camera. Cavanaugh answered in the negative.

Cavanaugh related that he and Murrah heard the radio dispatch call of a domestic disturbance call assigned to beat 513 at 10931 S Eberhart. Cavanaugh related that both he and Murrah decided to ride on the call. Cavanaugh related that additional information was given over the radio, which the caller stated that [REDACTED] was tearing up the house and was smoking crack cocaine. Cavanaugh related that upon their arrival to 10931 S Eberhart, he observed an M/1 standing at the front door holding it open.

Cavanaugh related that as he approached the residence the M/1 told Cavanaugh and Murrah that [REDACTED] is high on crack cocaine and is armed with a butcher knife. Cavanaugh related that he immediately notified the radio zone #9 that the offender is armed with a butcher knife. Cavanaugh related that he also requested for assist units.

Cavanaugh related that the M/1, [REDACTED] entered the residence first, his partner Murrah second and he last. Cavanaugh related that they entered the front door into a hallway (foyer,) then into a living room through an open door. Cavanaugh related that the living room was dark. Cavanaugh related that he observed the furniture was thrown all about, on its side. Cavanaugh related that he observed a dresser, curio cabinets and cupboards with broken glass and broken mirrors appearing as if the house had been ransacked.

Cavanaugh related that he and his partner, Murrah, began to call out for the F/1, NKA Angelique Styles. Cavanaugh related that he and Murrah repeatedly called out to Styles asking where she was and to come out and turn on the lights.

Cavanaugh related that he could see down the hallway and into a backroom in the rear of the residence. Cavanaugh related



that the light was on in the rear backroom.

Cavanaugh related that he could see Styles walk out of the backroom and into the hallway through the kitchen and into the hallway. Cavanaugh related that he could see that Styles was clenching a butcher knife in her right hand.

Cavanaugh related that Murrah turned his flashlight on in the living room and shone it on Styles. Cavanaugh related that he and Murrah began to order Styles to drop the knife. Cavanaugh related that Styles continued to walk toward all of them and as Styles crossed into the living room from the hallway, Styles raised the butcher knife up with the blade pointed in their direction and still refusing their orders to drop the knife, she lunged in their direction.

Cavanaugh, in fear for his life, his partner's life, and Mr. Phillip Styles' life, he discharged his weapon at Styles.

The R/D inquired how many times did Cavanaugh discharge his weapon in Styles' direction to eradicate the threat. Cavanaugh related that he believed that he discharged his service weapon four to five times.

Cavanaugh related that he saw the butcher knife that Styles had clenched in her right hand fly across the room towards [REDACTED]. Cavanaugh related that he believed that the threat was gone and holstered his weapon. Cavanaugh related that he observed Styles fall backwards towards a wall and slide down the wall on to the floor. Cavanaugh related that he radioed that the police fired shots and an ambulance was needed. Cavanaugh related that that he also requested a supervisor at the scene.

Officer Christopher Murrah #18003

Murrah related that he was assigned to beat 571 Wagon/ Van on today's date 24 Oct 2013, along with partner, Officer Ronald Cavanaugh #3274 in full uniform. The R/D inquired if Murrah was taser trained and currently qualified. Murrah related that he is not trained nor qualified to carry a department issued taser.

The R/D asked if the vehicle that Murrah was assigned to on 24 Oct 2013 was equipped with an in car camera. Murrah related that the vehicle was not equipped with cameras.

Murrah related that he and Cavanaugh heard the radio dispatch call of a domestic disturbance at 10931 S Eberhart. Murrah related that both he and Cavanaugh decided to ride on the call. Murrah related that additional information was given over the radio, which the caller stated that [REDACTED] was tearing up the house and was smoking crack cocaine. Murrah related that upon their arrival to 10931 S Eberhart, he observed an M/1 standing at the front door, holding it open.

Murrah related that the M/1, NKA [REDACTED] was waving them over to him. Murrah related [REDACTED] was gesturing excitedly, as to hurry them over to him. Murrah related that once at the front porch of the residence [REDACTED] related to them that [REDACTED] KNA Angelique Styles, is in the house and is armed with a knife.

Murrah related that he heard Cavanaugh notifying the dispatcher that someone in the house is armed with a butcher knife and requested additional units to assist them. Murrah went on to say that they all entered the residence at 10931 S Eberhart through the front door and while in the foyer lead the way into the living room in the following order, [REDACTED] Murrah second and Cavanaugh last. Murrah related that they entered the living room and it was dark the only light available was the front porch light, some light coming from the rear of the house and Murrah utilizing his flashlight.

Murrah related that he and Cavanaugh began to yell out "Police," "Police," "Lady can you come out and turn on the lights." Murrah related that there was no answer. Murrah related that the house was a wreck, furniture was turned over, and broken mirror and glass were on the floor. Murrah related that he saw Angelique Styles walk towards them from the rear of the house, down the hallway and into the living room. Murrah related that he could see that the F/1 was holding a butcher knife in her right hand. Murrah described the knife as a butcher knife, eight to ten inches long, with a silver blade and a white handle.

Murrah related that as Angelique Styles entered the living room area from the hallway, she raised the butcher knife using her right hand from her waist to raising it above her head while still walking towards them. Murrah related that he and Cavanaugh continued to order Angelique Styles to stop and drop the butcher knife. Murrah related that she refused their numerous commands to stop and drop the butcher knife. Murrah related that Ms. Styles lunged at him, Cavanaugh and [REDACTED].

Murrah related that he had his service weapon out and pointed at Angelique Styles, the whole time he and Cavanaugh gave the commands to stop and drop the butcher knife. Murrah related that he was about to discharge his weapon when he heard four to five shots and immediately knew his partner Cavanaugh had shot. Murrah related that Angelique Styles was six to eight feet away before his partner shot. Murrah related that the butcher knife flew across the living room towards [REDACTED]. Murrah related that the butcher knife fell at [REDACTED] feet.

Murrah related that he was aware that he was standing next to [REDACTED] who was just shot by his partner and immediately holstered his service weapon. Murrah related that he was aware that situations could change quickly. Murrah related that for their safety he asked [REDACTED] to sit down in the armchair nearest to [REDACTED]. Murrah related that he also asked [REDACTED] not to touch anything. Murrah related that an ambulance was called for [REDACTED].

The R/D asked Murrah what he saw the offender, Angelique Styles, do after being shot. Murrah related that he saw Angelique

Styles take some steps backwards and go down to the floor. Murrah related the he could see that Ms. Styles was shot and was having trouble breathing. Murrah related that Ms. Styles was not handcuffed. Murrah related that EMS arrived and gave first aid to Ms. Styles, and removed her to Advocate Christ Hospital in Oak Lawn, IL.

The investigation has established that on 24 Oct 2013, at 10931 S Eberhart Ms Angelique Styles lunged at Police Officers with a butcher knife placing them in fear of being killed or receiving great bodily harm. Ms Angelique Styles was then shot by Police Officer Cavanaugh in the line of duty to prevent death or great bodily harm to themselves and [REDACTED] It is requested that this case be classified as a Justifiable Homicide and CLOSED NON-CRIMINAL.
