Event# 15623, Above offender placed into custody after he was observed pointing a handgun at three uniformed Chicago Police Officers. These officers were responding to a person with a gun call at the above address. After numerous verbal commands to cease his actions, and failure to do so, Officer Sabella observed the offender remove the firearm that was aimed at his head and point it in the direction of Sgt. Holy. In fear of his life and the lives of fellow Officers fired his weapon striking the offender. The offender was taken into custody, advised of his rights and transported to the hospital by a Chicago Fire Department ambulance.
