EVENT #00205IN SUMMARY: WITNESS, [REDACTED] RELATED THAT HE OBSERVED THE ABOVE OFFENDER ENTER THE STORE, WALK TO THE LIQUOR AISLE, AND REMOVE A BOTTLE OF KETEL ONE VODKA (TOTALLING \$35.52 U.S.C.)
