INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT #13738 ABOVE OFFENDER PLACED UNDER ARREST AFTER HE WAS OBSERVED DRINKING ALCOHOL IN A VEHICLE ON THE PUBLIC WAY. AS A/O'S ATTEMPTED TO AFFECT THE ARREST THE OFFENDER EXITED THE VEHICLE AND REFUSED TO COMPLY WITH A/O'S VERBAL COMMANDS. ARRESTEE ATTACKED OFFICER KOZLOWSKI #13825 AND STRUCK HIM ABOUT THE RIGHT SHOULDER AND CHEST AREA WITH CLOSED FIST AND STRUGGLED AS OFFICER KOZLOWSKI #13825 ATTEMPTED TO PERFORM AN EMERGENCY TAKE DOWN. OFFENDER WAS ABLE TO BREAK FREE AND ENTER RESIDENCE OF 8412 S. MANISTEE, WHERE ARRESTEE CHARGED RESPONDING OFFICERS WITH A YELLOW METAL CUTTING INSTUMENT RESEMBLING A KNIFE AT WHICH TIME SGT. WALKER #2371 DISCHARGED HIS WEAPON IN ORDER TO PREVENT THE ARRESTEE FROM INJURING THE OFFICERS STRIKING THE OFFENDER IN THE RIGHT HIP AREA. FTO CHUDY ALSO DISCHARGED HIS TASER SIMULTANEOUSLY STRIKING THE OFFENDER AND BRINGING HIM DOWN. AFTER A BRIEF STRUGGLE THE OFFENDER WAS PLACED IN HAND CUFFS AND TRANSPORTED TO NORTHWESTERN HOSPITAL BY CFD #22 FOR TREATMENT. OFFENDER'S PERSONAL PROPERTY AND WEAPONS RECOVERED AND INVENTORIED BY BEAT#5824 E.T.SWAIN #3122. OFFENDER'S NAME CHECK WAS CLEAR WITH NO WANTS/WARRANTS, NO INVESTIGATIVE ALERTS, NOT ON PAROLE, NOT ON PROBATION, NOT ON GIPP AND NOT ON TWO DEGREES OF ASSOCIATION.
