IN SUMMARY, ABOVE PLACED UNDER ARREST FOR AGGRAVATED BATTERY IN THAT HE RAMMED ARRESTING OFFICERS VEHICLE WITH HIS OWN VEHICLE, WHICH THEN STRUCK BOTH OFFICERS, IN ATTEMPT TO EVADE/ESCAPE ARREST FOR IMPENDING INVESTIGATION OF NARCOTICS AND NARCOTICS SALES. DUE TO THE IMPACT OF THE CRASH, OFFICER WESSELHOFF SUSTAINED BACK INJURIES AND WAS ADMITTED TO NORTHWESTERN HOSPITAL. OFFICER MATEO SUSTAINED BACK INJURY AND ABRASIONS DUE TO IMPACT.
