EVENT# 00459 IN SUMMARY: WHILE ON THE SCENE OF A SHOOTING WHICH OCCURED IN THE AREA OF 53RD AND KING DRIVE, R/O'S OBSERVED LISTED VEHICLE PARKED AND UNOCCUPIED AT 5312 S. KING DRIVE. VEHICLE HAD THE REAR WINDOW SHOT OUT AND THERE WAS BULLET DAMAGE TO THE FRONT WINDSHIELD ON THE DRIVERS SIDE.
