EVENT#195670 THE ABOVE WAS ARRESTED FOR AGGRAVATED UUW/NO FOID AND AGGRAVATED ASSAULT TO P.O. AFTER UNIFORMED P.O COTTON AND P.O EVANS RESPONDED IN A MARKED FORD EXPLORER TO A GANG DISTURBANCE CALL AT 4739 SOUTH ADA. THE OFFICER OBSERVED THE ABOVE OFFENDER HOLDING A SILVER SEMIAUTOMATIC HANDGUN IN HIS RIGHT HAND AS HE FLED ON FOOT TO THE REAR ALLEY OF 4755 SOUTH ADA. AT THAT LOCATION THE OFFENDER POINTED THE WEAPON AT OFFICER COTTON. OFFICER COTTON IN FEAR OF BEING SHOT BY THE OFFENDER, FIRED AT THE OFFENDER STRIKING HIM SEVERAL TIMES. OFFENDER WAS TAKEN INTO CUSTODY AND HIS HAND GUN WAS RECOVERED AT 4755 SOUTH ADA IN THE ALLEY. WEAPON RECOVERED FROM OFFENDER IS A SILVER LLAMA .32 CALIBER SEMIAUTOMATIC HANDGUN SERIAL NO.606216 LOADED WITH SEVEN LIVE ROUNDS. CFD/AMB1 TRANSPORTED OFFENDER TO CHRIST HOSPITAL FOR MEDICAL ASSISTANCE.
