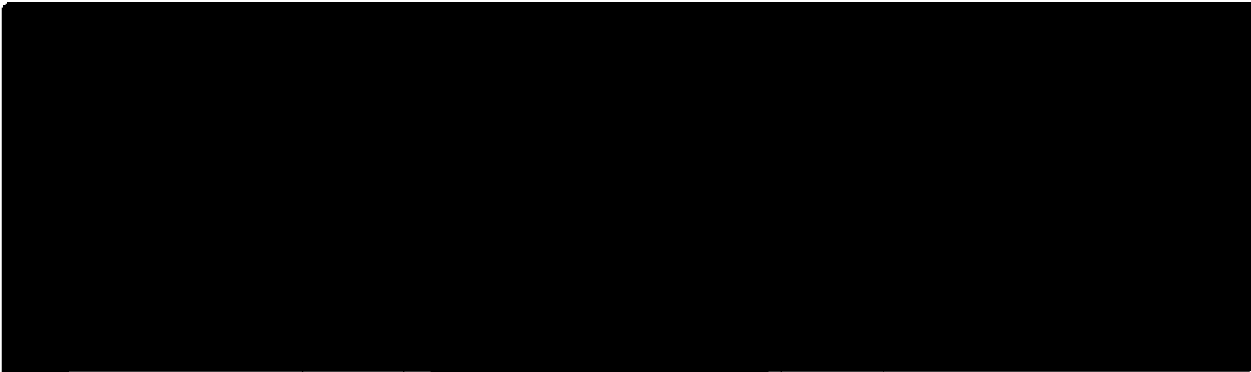

EVENTT#02643. IN SUMMARY R/O'S RESPONDED TO A BATTERY IN PROGRESS AT 4229 W. IRVING PARK (GOLDEN NUGGET RESTAURANT). ON SCENE R/O'S ARRIVED ON SCENE AND OBSERVED [REDACTED] (VICTIM) AND [REDACTED] (VICTIM). THE VICTIMS BOTH HAD VISIBLE INJURIES TO THE HEAD AND FACE THAT R/O'S BELIEVED NEEDED IMMEDIATE MEDICAL TREATMENT. WHILE ATTEMPTING TO GAIN INFORMATION FROM VICTIMS, [REDACTED] (VICTIM) AND [REDACTED] (VICTIM) STATED THAT THE OFFENDERS WERE POLICE OFFICERS. THE VICTIMS STATED THAT DURING A PHYSICAL ALTERCATION, AN UNK OFFICER STATED SOMETHING TO THE EXTENT OF " 25TH DISTRICT POLICE". WHEN THIS INFORMATION WAS GIVEN, R/O'S IMMEDIATELY REQUESTED EMS, 017TH DISTRICT SUPERVISOR ON SCENE, AND EVIDENCE TECHNICIAN VIA CITYWIDE 2 OVER RADIO. THE ONLY AVAILABLE 017TH DISTRICT SGT. (SGT. BUBALO 1730R) WAS IN THE STATION. R/O'S CALLED THE STATION VIA CELL PHONE AND TALKED TO 1730R OVER THE PHONE. R/O'S STATED THAT THE VICTIMS WERE BATTERED AND THEY ARE SAYING IT WAS FROM POLICE OFFICERS FROM THE 25TH DISTRICT. 1730R RELATED THAT HE WOULD BE LEAVING THE STATION SHORTLY TO COME ON SCENE. THE VICTIMS STATED THAT THEY WERE AT JOE E'S BAR ( 4206 W. IRVING PARK ROAD) DRINKING. THE VICTIMS LEFT THE BAR AND HEADED TO THE GOLDEN NUGGET WERE THEY BOTH HAD SOMETHING TO EAT. THE VICTIMS LEFT THE GOLDEN NUGGET AND WENT ON THE CORNER (IRVING PARK AND TRIPP, THE SOUTH EAST SIDE OF CORNER) AND WERE WAITING FOR A CAB. THATS WHEN SCOTT ROONEY#9550(OFFENDER), JOSHUA ALMODOVAR#19975(OFFENDER) AND JESUS DELGADO#10720(OFFENDER) STARTED A VERBAL ALTERCATION WITH THEM. [REDACTED]

[REDACTED] (WITNESS) THEN LEFT HIS LOCATION TO ATTEND TO THE VICTIMS. EMS#32, EMS#48 AND A CFD FIRE TRUCK (UNK NUMBER) ARRIVED ON SCENE. 1730R ARRIVED ON SCENE AND WAS INFORMED BY R/O'S OF INCIDENT. 1730R ENTERED AN AMBULANCE TO TALK TO THE VICTIMS BRIEFLY AND LEFT THE AMBULANCE. 1730R AND R/O'S THEN TRIED TO LOCATE ANY OUTSIDE CAMERAS ON IRVING PARK HOWEVER NONE COULD BE LOCATED. [REDACTED] (WITNESS) AND [REDACTED] (WITNESS) WERE APPROACHED R/O'S AND RELATED THAT THEY HAD CALLED 911. 1730R AND OFFICER PINZINE RELOCATED TO THE GOLDEN NUGGET AND INTERVIEW WITNESSES [REDACTED]





NARRATIVES

PART OF THIS STATEMENT FROM [REDACTED] (WITNESS) WAS OBTAINED OVER THE PHONE BY OFFICER PINZINE. WHILE STILL ON SCENE AT THE NUGGET, 1620R RESPONDED TO 911 CALL AND MET WITH SCOTT ROONEY#9550(OFFENDER), JOSHUA ALMODOVAR#19975(OFFENDER), AND JESUS DELGADO#10720(OFFENDER) WHERE ALL IDENTIFIED THEMSELVES AS OFF DUTY CHICAGO POLICE OFFICERS. R/O'S ALONG WITH 1730R RELOCATED TO MONTROSE AND CICERO. 1732R FOLLOWED EMS 32 AND 48 TO SWEDISH HOSPITAL WITH VICTIMS. R/O'S ARRIVED FIRST ON SCENE AT MONTROSE AND CICERO. SCOTT ROONEY#9550(OFFENDER), JOSHUA ALMODOVAR#19975(OFFENDER) AND JESUS DELGADO#10720(OFFENDER) WERE IN THE BACK OF AN UNK 16TH DISTRICT BEAT CAR AND 1620R WAS ON SCENE. THE THREE OFFENDERS EXITED THE SQUAD CAR AND WERE ASKED BY R/O'S IF THEY WERE THE POLICE AND THEY RESPONDED YES. THE ODPO'S THEN ATTEMPTED TO TELL R/O'S WHAT HAD HAPPENED AND R/O'S INSTRUCTED ODPO'S TO WAIT UNTIL A SGT IS ON SCENE. 1730R ARRIVED A FEW MINUTES LATER TO INTERVIEW SCOTT ROONEY#9550(OFFENDER), JOSHUA ALMODOVAR#19975(OFFENDER) AND JESUS DELGADO#10720(OFFENDER). R/O'S ALONG WITH 1730R OBSERVED ALL THREE TO HAVE A STRONG ORDER OF ALCHOLIC BEVERAGE ON THEIR BREATH AND ALL THREE STATED THAT THEY HAD BEEN DRINKING. SCOTT ROONEY#9550(OFFENDER) AND JOSHUA ALMODOVAR#19975(OFFENDER) STATED THEY WERE BOTH AT JOE E'S BAR LOCATED AT 4206 W. IRVING PARK ROAD. [REDACTED] (VICTIM) BUMPED INTO JOSHUA ALMODOVAR#19975(OFFENDER) AND BEGAN SHOUTING GANG SLOGANS "GD, CPD KILLA". JOSHUA ALMODOVAR#19975(OFFENDER) RELATED THAT HE ATTEMPTED TO "CALM" [REDACTED] (VICTIM) DOWN. [REDACTED] (VICTIM) WAS STILL WAS VISIBLY UPSET AND WAS INFORMED BY JOSHUA ALMODOVAR#19975(OFFENDER) THAT WE WAS AN OFF DUTY POLICE OFFICER. [REDACTED] (VICTIM) AT THIS TIME DISPLAYED A PITCHFORK GANG SYMBOL WITH HIS HANDS TO JOSHUA ALMODOVAR#19975(OFFENDER). [REDACTED] (VICTIM) THEN STATED "25TH DISTRICT COP KILLER". SCOTT ROONEY#9550(OFFENDER) AND JOSHUA ALMODOVAR#19975(OFFENDER) THEN EXITED LOCATION TO HAVE A CIGARETTE. [REDACTED] (VICTIM) AND [REDACTED] (VICTIM) THEN LEFT THE BAR TO GO OUTSIDE. [REDACTED] (VICTIM) THEN STATED TO SCOTT ROONEY#9550(OFFENDER) AND JOSHUA ALMODOVAR#19975(OFFENDER) "HAVE YOU KILLED", "HOW MANY HAVE DIED" WHO THEN STARTED TO CRY. SCOTT ROONEY#9550(OFFENDER) AND JOSHUA ALMODOVAR#19975(OFFENDER) TRY TO CALM [REDACTED] (VICTIM) THEN GO INTO THE BAR AND PAY THEIRS BEERS. [REDACTED] (VICTIM) AND [REDACTED] (VICTIM) LEFT SCENE AND STARTED WALKING TO THE GOLDEN NUGGET. SCOTT ROONEY#9550(OFFENDER) AND JOSHUA ALMODOVAR#19975(OFFENDER) ALSO LEFT AND BEGAN WALKING TO THE GOLDEN NUGGET. [REDACTED] (VICTIM) AND [REDACTED] (VICTIM) BEGAN TO PROVOKE ODPO'S BY SAYING " WHAT THE FUCK YOU LOOKING AT", "FUCK CPD". AT THIS POINT, SCOTT ROONEY#9550(OFFENDER), JOSHUA ALMODOVAR#19975(OFFENDER) [REDACTED] (VICTIM) AND [REDACTED] (VICTIM) WERE IN THE FRONT OF THE NUGGET. [REDACTED] (VICTIM) STATED " WE HAVE SOMETHING FOR YOU" AND MADE MOVEMENTS TO HIS WAISTBAND IMPLYING THAT HE HAD A FIREARM. [REDACTED] (VICTIM) OR [REDACTED] (VICTIM) PUSHED SCOTT ROONEY#9550(OFFENDER) IN THE CHEST. SCOTT ROONEY#9550(OFFENDER) AND JOSHUA ALMODOVAR#19975(OFFENDER) RELOCATED INSIDE WHERE JESUS DELGADO#10720(OFFENDER), SGT. WOZIAK (WITNESS) AND OFFICER FERLTIO (WITNESS) WERE LOCATED. SCOTT ROONEY#9550(OFFENDER) AND JOSHUA ALMODOVAR#19975(OFFENDER) THEN ASKED JESUS DELGADO#10720(OFFENDER) IF HE HAD HANDCUFFS OR A HANDGUN TO WHICH HE REPLIED NO. SCOTT ROONEY#9550(OFFENDER), JOSHUA ALMODOVAR#19975(OFFENDER) AND JESUS DELGADO#10720(OFFENDER) EXITED THE NUGGET TO TALK TO [REDACTED] (VICTIM) AND [REDACTED] (VICTIM). OUTSIDE [REDACTED] (VICTIM) AND [REDACTED] (VICTIM) STARTED A VERBAL ALTERCATION WITH THE THREE ODPO'S. JOSHUA ALMODOVAR#19975(OFFENDER) STATED THAT HE WAS PUNCHED IN THE FACE, RECIEVED SCRATCHES ON HIS FACE AND WAS THROWN TO THE GROUND BY [REDACTED] (VICTIM). AN UNK OFFENDER DELIVERED JESUS DELGADO#10720(OFFENDER) SEVERAL PUNCHES TO THE FACE FROM UNK OFFENDER. SCOTT ROONEY#9550(OFFENDER) WAS PUNCHED IN THE FACE BY [REDACTED] (VICTIM). ALL THREE OFFICERS THEN STATED THEY LEFT THE SCENE BECAUSE THEY WERE IN FEAR OF [REDACTED] (VICTIM) AND [REDACTED] (VICTIM) TRYING TO OBTAIN A GUN. THE THREE OFFICERS LEFT SCENE IN JESUS DELGADO#10720(OFFENDER) VEHICLE AND CALLED 911 TO REPORT THE INCIDENT ABOUT 30 MINUTES LATER. 1730R STATED TO ALL THREE OFFICERS THAT THEY WOULD HAVE TO DO A BREATH TEST AT THE STATION. R/O'S WAITED FOR THE STREET DEPUTY TO COME OUT AND CHARGES ARE PENDING AS OF THIS REPORT. BT 5836 ON SCENE FOR PHOTOS OF ALL PARTIES INVOLVED.
