EVENT# 09109, IN SUMMARY: R/Os WERE CONDUCTING A NARCOTICS INVESTIGATION WHERE OFFENDER GOLATTE WAS OBSERVED TO CONDUCT TWO (2) SEPARATE, SUSPECT NARCOTIC TRANSACTIONS. A/Os PERFORMED A TRAFFIC STOP AT ABOVE LOCATION TO CONDUCT A FIELD INTERVIEW. OFFENDER GOLATTE THEN SHIFTED HIS VEHICLE IN REVERSE IN THE DIRECTION OF P.O. WHIGHAM, STRIKING SQUAD. OFFENDER GOLATTE THEN SHIFTED HIS VEHICLE IN DRIVE TOWARDS A/Os GAETA, MATHEOS, AND DERCOLA. OFFICERS MATHEOS AND GAETA THEN DISCHARGED THEIR WEAPONS IN THE DIRECTION OF OFFENDER GOLATTE. OFFENDER GOLETTE'S VEHICLE THEN CAME TO A STOP AT 321 W. 115TH ST. WHERE HE EXITED HIS VEHICLE AND THEN SUBSEQUENTLY PLACED INTO CUSTODY. OFFENDER GOLETTE WAS THEN TRANSPORTED TO CHRIST HOSPITAL. NAME CHECK CLEAR. NO I/As. NOT ON GIPP OR TDOA. NOT A POD ARREST. DOCUMENTED GANGSTER DISCIPLE. INVENTORIED: (#13370146) 1 GRAY SOCK AND 7 PLASTIC ZIPLOCK BAGS EACH WITH SUSPECT CANNABIS INSIDE.
