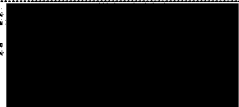

 EVENT# 00318 ABOVE PLACED INTO CUSTODY IN THAT; A/O'S WERE ON PATROL AND SUBSEQUENTLY CONDUCTED A PLATE CHECK OF THE ABOVE LISTED VEHICLE VIA PDT. THE VEHICLE REGISTRATION CAME BACK STOLEN,(LISTED UNDER RD#HY150455). A/O'S ATTEMPTED TO CURB SAID VEHICLE, AT WHICH TIME THE LISTED VEHICLE SPED OFF STRIKING SEVERAL PARKED VEHICLES AND A/O'S SQUAD CAR (LISTED UNDER RD#HY151017). A/O'S APPROACHED THE VEHICLE AT WHICH POINT THE ABOVE OFFENDER WOULD NOT FOLLOW VERBAL COMMANDS, IN THAT HE(ROBERTSON, DARELL) PUT THE VEHICLE IN DRIVE and sped forward towards the officers, in which the officers had to quickly move out of the way in order not to get hit by the vehicle. Offender then struck another vehicle, then drove the car in reverse. Above offender THEN BEGAN REMOVING A GUN FROM HIS CHEST AREA, PLACING A/O'S(ZAVALA, PIPER, ANTONSEN) IN FEAR FOR THEIR LIVES. A/O'S PIPER AND ZAVALA FEARING FOR THEIR LIVES DISCHARGED THEIR WEAPONS STRIKING THE OFFENDER. OFFENDER TAKEN INTO CUSTODY. WEAPON RECOVERED FROM OFFENDERS INSIDE JACKET POCKET.(RUGER 9MM DEFACED SERIAL NUMBER-6LIVE ROUNDS).
