IN SUMMARY, WHILE ON PATROL, A/O'S OBSERVED LISTED VEHICLE MAKING A LEFT TURN WHILE TRAVELING W/B AROUND A TRAFFIC ISLAND AND RETURN E/B ALMOST STRIKING A/O'S VEHICLE WHILE A/O'S WERE TRAVELING W/B ON POLK BY VEERING INTO THE W/B LANE AND THEN PROCEEDED TO PARK WHILE A/O'S TURNED VEHICLE AROUND AT NEAREST INTERSECTION NEVER LOSING SIGHT OF THE VEHICLE. AS A/O'S APPROACHED OFFENDER IMMEDIATELY EXITED THE VEHICLE FROM THE DRIVERS SIDE DOOR. A/O'S ASKED FOR OFFENDER TO RETURN TO THE VEHICLE TO WHICH SHE DID NOT COMPLY. A/O FURLET #6211 WENT TO DETAIN OFFENDER WHO WAS TRYING TO ENTER THE GATE AT LISTED ADDRESS. WHILE ATTEMPTING TO DETAIN OFFENDER, OFFENDER ATTEMPTED TO BREAK AWAY FROM A/O FURLET AND RAISED HER RIGHT ARM WITH A CLOSED FIST AT WHICH POINT A/O FURLET #6211 PERFORMED CONTROL HOLDS TO PLACE OFFENDER INTO CUSTODY.
