AS BT 133HR APPROACHED, VICTIM SHOUTED THAT THE OCCUPANTS OF THE KIA THAT JUST DROVE OFF HAD JUST ROBBED CELLPHONE AND WALLET, BT 124R THEN PUT IN HIS CAR WHILE TRACKED THE VICTIM'S PHONE.
