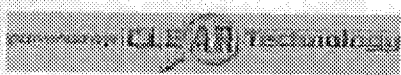

NARRATIVE

EVENT#:01428. IN SUMMARY, VICTIM RELATED [REDACTED] WAS STANDING IN THE STREET ON 21ST STREET BETWEEN STATE AND WABASH, WITH [REDACTED] FRIEND, [REDACTED] WITH HIS BACK TO THE STREET WHEN [REDACTED] OBSERVED OFFENDERS DROVE SLOWLY PAST [REDACTED] WEST BOUND. [REDACTED] THEN OBSERVED THE FRONT AND REAR PASSENGERS, THE FIRST AND SECOND OFFENDERS GET OUT OF THE CAR AND WALK EAST TOWARD [REDACTED] THE THIRD OFFENDER, THE DRIVER, NEVER GOT OUT OF THE VEHICLE. OFFENDER #1, HOGANS, TERRANCE, SUDDENLY PULLED OUT A GUN AND PUT IT TO VICTIM'S SIDE AND VICTIM STATED THAT "I AIN'T GOT ANYTHING". OFFENDER #1 THEN SAID "YOU KNOW WHAT THIS IS" AND THEN PUT THE GUN TO VICTIM'S HEAD WHILE HE WENT THROUGH [REDACTED] POCKETS. [REDACTED] THEN RAN EAST AND SOUTH WHERE [REDACTED] FLAGGED DOWN BT 133HR. AS BT 133HR APPROACHED, VICTIM SHOUTED THAT THE OCCUPANTS OF THE KIA THAT JUST DROVE OFF HAD JUST ROBBED [REDACTED] OF [REDACTED] CELLPHONE AND [REDACTED] WALLET. BT 124R THEN PUT [REDACTED] IN HIS CAR WHILE [REDACTED] TRACKED THE VICTIM'S PHONE. THE PHONE AND CAR WERE LOCATED AT 43RD/PARNELL. BTS 124R AND 133HR THEN TRACKED THE PHONE TO THIS LOCATION WHERE THE OFFENDERS WERE TAKEN INTO CUSTODY. SEE DETECTIVES' SUPPLEMENTARY REPORT.
