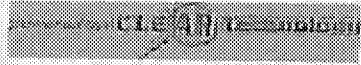

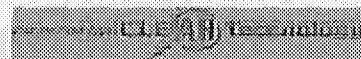

MANNER/MOTIVE:

Unknown offender armed with a handgun robbed the victim at 21st and State of his wallet and cell phone and fled in a small 4 door gray vehicle. Victim flagged down the police and related what had happen, responding units toured the area with victim. Victim used the witness 1 phone to find his phone which indicated that his 1 phone was at 43rd and Parnell. Responding units arrived at

43rd and Parnell and observed the offenders in a gray 4 door Kia headed westbound at 540 W. 43rd street. Victim and witness identified the vehicle and the vehicle was curbed. As the officers approached on foot the offender's in the front passenger's seat exited the vehicle and refused to show his hands after verbal commands. Offender exited the vehicle and rushed toward the victim/officer. Victim observed that the offender had a handgun in his waistband and the offender struck the victim/officer in the chest with his forearm, the officer related that he feared for his life when the offender rushed toward him with the handgun and fired one gunshot and was not sure if the offender was shot. The victim/officer related that the offender dropped a handgun as he fled southbound Parnell. The Glock 17 handgun was recovered and a search for the offender was negative. /Armed Robbery

INVESTIGATION:

R/ds were assigned a police shooting at 540 W. 43rd Street by Sgt. K. Williams #847 of this command. Information related that an unknown Armed Robbery suspect exited a small vehicle with a handgun in his waistband. The offender ran toward the victim/officer and struck the victim/officer in the chest with a forearm. Information related that the victim/officer fired one gunshot and the offender fled eastbound from that location. Information related that a handgun was recovered and two additional robbery offenders were being detained for this investigation. R/d relocated to 540 W. 43rd Street for this investigation.

R/d arrived and observed that the area is residential with single family homes. R/d observed that the area had been cordoned off with yellow crime scene tape. 009th district personnel were assigned to guard the crime scene. Inside of the crime scene tape R/d observed that Beat 133HR vehicle was positioned directly behind the offender's vehicle a gray 2005 Kia Spectra and Beat 124R vehicle was positioned directly in front of the gray 2005 Kia Spectra. All three vehicles were directly in front of 540 W. 43rd Street. R/d observed that one spent 9mm shell casing was located on the sidewalk in front of 540 W. 43rd Street.

R/d interviewed victim/officer Rothiel Davis #7558 and his partner officer Lee #17554 were in prescribe Chicago Police attire in a mark squad car when they were flagged by witness [REDACTED] at 21st and State Street. P.O Davis related that unknown offenders robbed victim [REDACTED] and one of the offender's put a handgun to the victim's head.

P.O Davis related that the victim entered [REDACTED] vehicle and they toured the area looking for the offenders. P.O Davis stated that victim [REDACTED] used witness [REDACTED] phone with the find my phone feature and tracked his I phone to 43rd and Parnell. P.O Davis related that he and beat 124R arrived on the scene and observed a small gray Kia with three male occupants traveling westbound on 43rd Street. P.O Davis related that the vehicle had a damage front tire. P.O Davis related that beat 124R positioned it's vehicle directly in front of the offender's vehicle and P.O Davis related that they positioned there vehicle directly behind the offender's vehicle. P.O Davis stated that the victim and witness both identified this vehicle as the one that the offender jumped into after the Robbery. P.O Davis related that because it was an Armed Robbery they approached the vehicle with caution and ordered all occupants in the vehicle to show their hands. P.O Davis related that the front passenger was not complying and was holding a container of nachos. P.O Davis related that the offender exited the vehicle dropping the container of food and Davis related that he could see a black handgun in his waistband. P.O Davis related that the offender rushed toward him and his weapon was drawn and the offender struck him in the chest with his forearm and he fired one gunshot. P.O Davis related that the offender fled eastbound and then southbound on Parnell dropping the black handgun with the extended clip to the pavement. P.O Davis related that he recovered the handgun and the offender jumped an iron fence. A search of the area for the offender was negative.

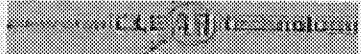
A show up was conducted at the scene and [REDACTED] identified Khalil POWELL as being one of the offenders that robbed him. Both subjects POWELL and BELTON was transported to Area Central for this investigation.

R/d received information that a shooting victim was at Mercy Hospital with a gunshot wound to the left arm and chest. Beat 124R, P.O R. Williams #10050 relocated to Mercy Hospital and positively identified this person Terrance L. HOGANS as the person that he observed with the handgun that fled at 43rd and Parnell. A photo array was conducted at Area Central and victim [REDACTED] and witness [REDACTED] both identified a photo of Terrance HOGANS as the person that Robbed victim [REDACTED]

R/d was also informed that an earlier Armed Robbery occurred at 3737 S. Vincennes at 0205 hours and reported under RD#HY-242453. Information related that the victim was shot with a 9mm handgun and the victim description of the offenders, weapon and vehicle matched the offenders in custody from the Armed Robbery in the 1st District.

Felony Review contacted and ASA Sam Cervera and Jim Murphy arrived for this investigation. ASA Sam Cervera and Jim Murphy were advised of all the facts to this case and interviewed the victim and all witnesses to this case and continue this investigation pending the results of the ballistic test involving the spent shell casings and the recovered Glock handgun.
