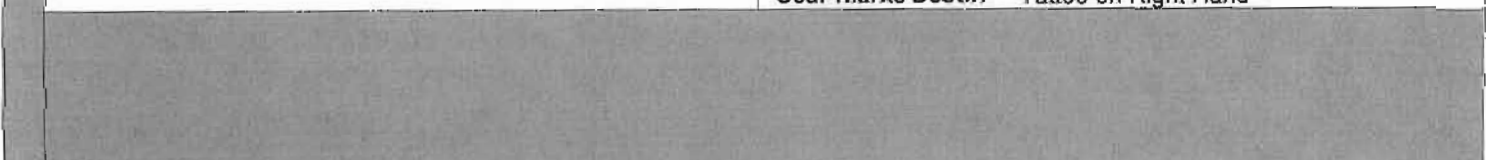

NARRATIVE

EVENT #14094; IN SUMMARY HECTOR MENDEZ (VICTIM) WAS THE DRIVER OF A VEHICLE INVOLVED IN A TRAFFIC CRASH WITH A VEHICLE DRIVEN BY [REDACTED] (WITNESS). MIGUEL GAMA(OFFENDER), LUTERIO MIRANDA(OFFENDER), AND ADRIAN OCAMPO(OFFENDER) WERE PASSENGERS OF THE VEHICLE DRIVEN BY [REDACTED] (WITNESS). AFTER THE ACCIDENT BOTH VEHICLES PULLED INTO A PARKING LOT LOCATED AT 6816 W GRAND AVE. MIGUEL GAMA(OFFENDER), LUTERIO MIRANDA(OFFENDER), AND ADRIAN OCAMPO(OFFENDER) EXITED THE VEHICLE DRIVEN BY [REDACTED] (WITNESS). ADRIAN OCAMPO(OFFENDER) AND MIGUEL GAMA(OFFENDER) BEGAN TO WALK TOWARD HECTOR MENDEZ (VICTIM) WITH BALLED FISTS AND LUTERIO MIRANDA(OFFENDER) APPROACHED WITH A BEER BOTTLE IN HIS HAND WHILE ALL WERE YELLING EXPETIVES DIRECTED TOWARD VICTIM. HECTOR MENDEZ (VICTIM) IDENTIFIED HIMSELF AS A COOK COUNTY SHERIFF AND OFFENDERS CONTINUED TO ADVANCE ON HECTOR MENDEZ (VICTIM) CAUSING HIM TO BELIEVE OFFENDERS WERE GOING TO BATTER HIM. OFFENDERS FLED THE SCENE WHEN THEY HEARD THE APPROACHING POLICE VEHICLES. P.O. VOGT AND P.O. GOLDEN TOURED THE AREA WITH [REDACTED] (WITNESS) WHO IDENTIFIED ADRIAN OCAMPO(OFFENDER) AND MIGUEL GAMA(OFFENDER) AS TWO OF THE PEOPLE WHO ASSAULTED HECTOR MENDEZ (VICTIM) WHEN SHE SAW THEM WALKING ON ALTGELD TOWARD OAK PARK AVE. VOGT AND GOLDEN PLACED ADRIAN OCAMPO(OFFENDER) IN CUSTODY AND SHORTLY AFTERWARD PLACED MIGUEL GAMA(OFFENDER) IN CUSTODY. DURING A CUSTODIAL SEARCH OF ADRIAN OCAMPO(OFFENDER) VOGT DISCOVERED A CLEAR KNOTTED SANDWICH BAG CONTAINING A GREEN CRUSHED PLANT PRODUCT, SUSPECT CANNABIS (INVENTORY #13431498), IN THE FRONT RIGHT PANT POCKET OF ADRIAN OCAMPO(OFFENDER). WHILE AWAITING A TRANSPORT ADRIAN OCAMPO(OFFENDER) ATTEMPTED TO PULL AWAY FROM VOGT AND FLEE. VOGT PERFORMED AN EMERGENCY TAKE DOWN OF ADRIAN OCAMPO(OFFENDER) AND HE CONTINUED TO PULL AWAY WHILE ON THE GROUND GOLDEN PERFORMED A DRIVE STUN WITH HIS TASER ON ADRIAN OCAMPO(OFFENDER). MIGUEL GAMA(OFFENDER) WHO WAS INTOXICATED AND SUPPORTED BY GOLDEN, ATTEMPTED TO INCAPACITATE GOLDEN BY PLACING HIS LEG BETWEEN GOLDEN'S LEGS, ATTEMPT TO TRIP GOLDEN, AND USE HIS BODY TO KNOCK GOLDEN TO THE GROUND. BEFORE MIGUEL GAMA(OFFENDER) WAS ABLE TO COMPLETE THIS TASK, GOLDEN PERFORMED AN EMERGENCY TAKE DOWN, STRIKE TO UPPER TORSO WITH CLOSED FIST AND PRESSURE POINTS ON MIGUEL GAMA(OFFENDER). DURING THE EMERGENCY TAKE DOWN MIGUEL GAMA(OFFENDER) SUSTAINED A BRUISE TO THE FOREHEAD. MIGUEL GAMA(OFFENDER) COMPLAINED OF LOSS OF BREATH AND NEEDED HELP. GOLDEN PUT MIGUEL GAMA(OFFENDER) IN THE SEATED POSITION, WHERE MIGUEL GAMA(OFFENDER) STILL COMPLAINED AND SEEMED DISTRESSED. DURING MIGUEL GAMA(OFFENDER)'S TIME SITTING DOWN, GOLDEN USED HIS KNEE TO PROP MIGUEL GAMA(OFFENDER) AND MIGUEL GAMA(OFFENDER) WAS STILL TRYING TO CAUSE HARM TO GOLDEN, BY USING HIS BODY AND WEIGHT AND STRIKING GOLDEN'S KNEE. GOLDEN STEPPED OUT OF THE WAY AND ARRESTEE FELL BACK ON THE GROUND. MEANWHILE P.O. LEARNAHAN #19366 WAS DIRECTED BY A CITIZEN THAT LUTERIO MIRANDA(OFFENDER) HAD FLED INTO THE BACKYARD OF 2541 N RUTHERFORD. LEARNAHAN ENTERED THE BACKYARD WITH P.O. GIBBONS #11265 AND CENTENO 15886 AND SAW LUTERIO MIRANDA(OFFENDER) IN THE YARD. P.O. GIBBONS#11265 OBSERVED LUTERIO MIRANDA(OFFENDER) THROW AN OBJECT ON THE ROOF OF THE GARAGE AT 2543 N RUTHERFORD. THE THROWN OBJECT WAS RETRIEVED BY P.O. CENTENO #15886 AND IT WAS A CLEAR PLASTIC BAG CONTAINING NUMERIOUS ZIP LOCK BAGGIES CONTAINING A GREEN LEAFY SUBSTANCE (INVENTORY #19366), SUSPECT CANNABIS. LUTERIO MIRANDA(OFFENDER) WAS TRANSPORTATED BACK TO DEL RAY'S MARKED AND POSITIVELY IDENTIFIED AS THE OFFENDER IN THE ASSAULT. VICTIM GIVEN VIN. AT THE 025TH DISTRICT STATION MIGUEL GAMA(OFFENDER) CONTINUED TO CLAIM DIFFICULTY BREATHING AND WAS TRANSPORTED TO WEST SUBURBAN HOSPITAL BY EMS 63. ADRIAN OCAMPO(OFFENDER) WAS TRANSPORTED TO OUR LADY OF THE RESSURECTION TO BE EVALUATED AFTER BEING TASED.
