UPON APPROACH TO SCENE R/O'S WERE FLAGGED DOWN BY [REDACTED] (WITNESS) WHO WAS YELLING THAT HIS BROTHER HECTOR MENDEZ (VICTIM AND COMPLAINANT) WAS BEING ATTACKED IN THE PARKING LOT OF LISTED LOCATION. WILDER R. #19951 (WITNESS) AND RAMOS M #12622 (WITNESS) OBSERVED LISTED VEHICLE ATTEMPTING TO LEAVE.
