<b>NARRATIVES</b>	EVENT # 246491 IN SUMMARY: THE VICTIM STATED THAT HE WAS ARRESTED ON 03 MAY 2015 UNDER CB# 019108269 AT APPROX. 2000 HRS. THE SUBJECT WAS TAKEN TO 025 DISTRICT FOR PROCESSING. VICTIM STATED THAT WHILE BEING PROCESSED HE BUMPED INTO ONE OF THE LOCKUP KEEPERS. AT THIS TIME THE MALE WHITE LOCKUP KEEPER PUT THE VICTIM FACE DOWN ONTO THE GROUND AND PLACED HIS KNEE INTO VICTIM BACK. VICTIM STATED THAT THE MALE BLACK LOCKUP KEEPER WALKED IN FRONT OF HIM WHILE STILL ON THE GROUND AND REPEATEDLY KNEED HIM IN THE FACE. BEAT 1630 INTERVIEWED THE VICTIM, AND GENERATED COMPLAINT # 10749884 PER A TOUSANT AT 1155 HRS. R/O REQUESTED ET TO SCENE TO TAKE PICTURES OF VICTIMS FACE.
