THE NEXT UPDATE WAS AN ASSAULT AND BEER BOTTLE BEING THROWN. UPON ARRIVAL THE VEHICLES FROM THE AUTO ACCIDENTS WERE IN THE DEL RANCHO MARKET PARKING LOT AND VICTIM MENDEZ RELATED THAT AFTER A MINOR TRAFFIC CRASH, THE VEHICLES WERE MOVED INTO THE PARKING LOT AND ABOVE OFFENDER EXITED THE OFFENDING VEHICLE .
