(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

EVENT 14094 IN SUMMARY ARRESTED ON SIGNED COMPLAINTS, IN THAT HE WAS A PASSENGER OF A VEHICLE INVOLVED IN A MINOR TRAFFIC ACCIDENT. ARRESTEE AND CO-ARRESTEES EXITED AND WALKED TOWARDS VICTIM AND THREATENED VICTIM WITH HIS DEMEANOR AND CLENCHED FISTS. VICTIM TOLD THE CO-ARRESTEES THAT HE WAS AN OFF DUTY SHERRIF'S POLICE. THIS STATEMENT DID NOT DETER THE CO-ARRESTEES AND THEY CONTINUED WITH THE ASSAULT. VICTIM WAS PUT IN FEAR OF HIS LIFE, CALLED 911 AND WENT TO HIS CAR AND GOT "THE CLUB", A CAR SECURITY DEVICE, FOR HIS PROTECTION. WHEN POLICE ARRIVED AND WITH THE SOUND OF APPROACHING SIRENS, CO-ARRESTEES FLED THE SCENE. A BRIEF DESCRIPTION WAS GIVEN TO THE POLICE BY FEMALE WITNESS AND A FLASH WAS GIVEN, AND DIRECTION OF FLIGHT. THE WITNESS VOLUNTEERED TO TOUR WITH A/O'S AND A SHORT TIME LATER AT LOCATION OF ARREST, WITNESS POSITIVELY IDENTIFIED THE 3 OFFENDERS. ARRESTEE AND CO ARRESTEE OCAMPO(CB19108265) WERE PLACED INTO CUSTODY. WHILE WAITING FOR TRANSPORTATION, ARRESTEE WHO WAS INTOXICATED AND SUPPORTED BY A/O GOLDEN, ATTEMPTED TO INCAPACITATE A/O BY PLACING HIS LEG BETWEEN A/O'S LEGS, ATTEMPT TO TRIP A/O, AND USE HIS BODY TO KNOCK A/O TO THE GROUND. BEFORE ARRESTEE WAS ABLE TO COMPLETE THIS TASK, A/O PERFORMED AN EMERGENCY TAKE DOWN. STRIKE TO UPPER TORSO WITH CLOSED FIST AND PRESSURE POINTS. ARRESTEE COMPLAINED OF LOSS OF BREATH AND NEEDED HELP. A/O PUT ARRESTEE IN THE SEATED POSITION, WHERE ARRESTEE STILL COMPLAINED AND SEEMED DISTRESSED. DURING ARRESTEE'S TIME SITTING DOWN, A/O USED HIS KNEE TO PROP ARRESTEE AND ARRESTEE WAS STILL TRYING TO CAUSE HARM TO A/O, BY USING HIS BODY AND WEIGHT AND STRIKING A/O'S KNEE. A/O STEPPED OUT OF THE WAY AND ARRESTEE FELL BACK ON THE GROUND. CO-ARRESTEE MIRANDA CB19108313 ARRESTED BY BT 2593 AT 2541 N RUTHERFORD. ARRESTEE TRANSPORTED TO 025 FOR PROCESSING.
