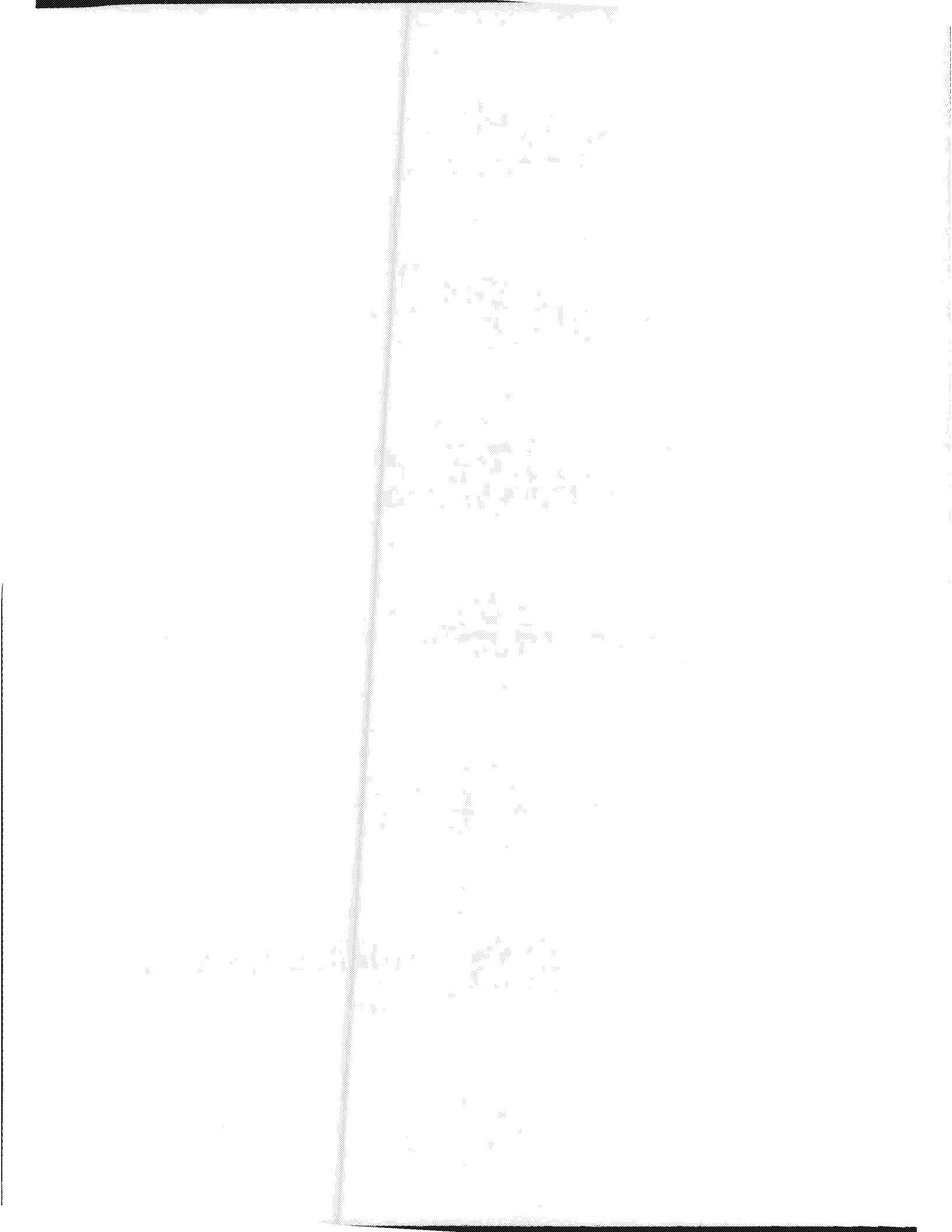

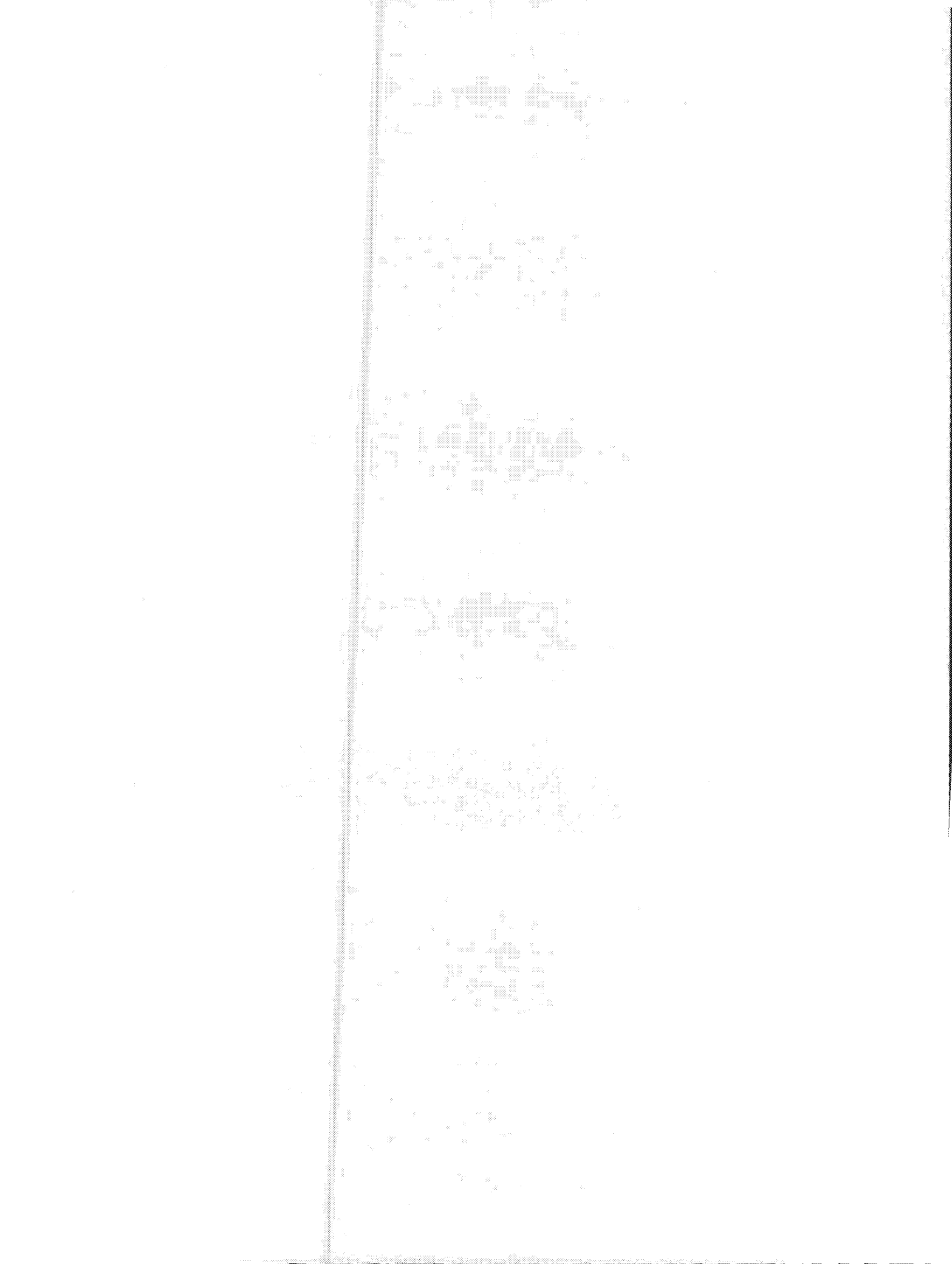

EVENT#00791 IN SUMMARY: EVENT#00791 IN SUMMARY R/O'S RESPONDING TO AN ASSIT FOR 0410R FOR A VEHICLE THEFT IN PROGRESS ARRIVED ON SCENCE IN THE ALLEY OF ██████ EAST END, OBSERVED A VEHICLE IN THE GARAGE OF THAT LOCATION WITH THE REAR WINDOW SHATTERED AND JIMMIE MILLER(OFFENDER) IN THE FRONT PASSENGER SIDE OF LISTED VEHICLE. JIMMIE MILLER(OFFENDER) DETAINED AT THAT TIME. R/O'S SPOKE WITH ██████ WHO RELATED TO R/O'S SHE OBSERVED JIMMIE MILLER(OFFENDER) REMOVE A ROCK FROM THE GROUND THEN THROW THE ROCK THREW THE REAR WINDOW, SHATTERING THE REAR WINDOW OF LISTED VEHICLE, THEN REMOVE THE ROCK FROM THE VEHICLE AND THROW THE ROCK ATOP THE GARAGE AT 7714 S RIDGELAND. ██████ ALSO RELATED TO R/O'S THAT AFTER THROWING THE ROCK JIMMIE MILLER(OFFENDER) REMOVED A WHITE PLASTIC BAG, BLACK PLASTIC BAG AND A 24 CASE OF BOTTLED WATER FROM INSIDE THE TRUNK OF THE VEHICLE. ██████ RELATED TO R/O'S THAT AFTER JIMMIE MILLER(OFFENDER) PLACED THOSE ITEMS ON THE GROUND, HE CLIMBED INTO THE VEHICLE THROUGH THE SHATTERED REAR WINDOW. ██████ POSITIVELY IDENTIFIED JIMMIE MILLER(OFFENDER) AS THE OFFENDER. ██████ IS THE REGISTERED OWNER OF LISTED VEHICLE. 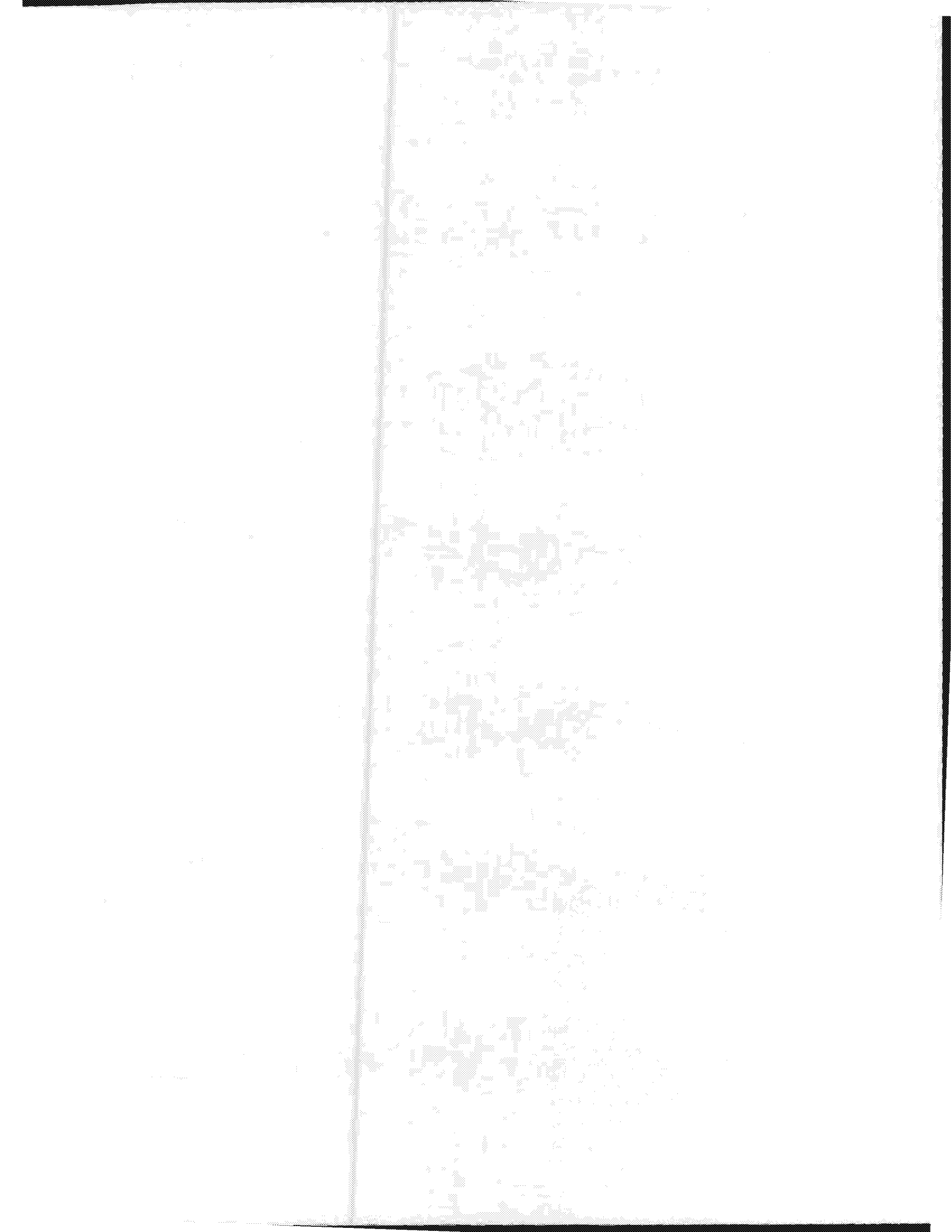
