EVENT # 00263 - IN SUMMARY, R/O'S RESPONDED TO SCENE OF EARLIER 10-1 CALL AT PORTILLOS RESTAURANT. UPON ARRIVAL, R/O'S SPOKE WITH K SHAAR (VICTIM AND COMPLAINANT), WHO RELATED THAT HE WAS OFF DUTY CPD AND HAD BEEN WORKING SECURITY AT THE RESTAURANT AND HAD INFORMED TERENCE CLARKE(OFFENDER) SEVERAL TIMES THAT THE RESTAURANT WAS CLOSING AND THAT HE HAD TO LEAVE THE PREMISES. OFFENDER THEN BECAME BELLIGERENT AND TOLD VICTIM, " DO WHATEVER THE FUCK YOU HAVE TO DO, I'M NOT LEAVING." AT THIS POINT, OFFENDER THEN THREW A CUP OF CHEESE AT VICTIM. VICTIM ANNOUNCED HIS OFFICE, ONCE MORE ADVISED THE OFFENDER TO LEAVE OR BE ARRESTED. OFFENDER AGAIN REFUSED TO COMPLY. VICTIM THEN PROCEEDED TO CALL 911 AND REMOVED HIS HANDCUFFS FROM THEIR POUCH AND WAS ATTEMPTING TO PLACE OFFENDER IN CUSTODY WHEN OFFENDER RESISTED ARREST THEN STARTED STRIKING VICTIM WITH CLOSED FISTS AND SWUNG A CHAIR AT VICTIM, STRIKING HIM. VICTIM DEFENDED HIMSELF BY STRIKING THE OFFENDER IN THE HEAD AND FACE WITH HIS RIGHT HAND, WHICH CONTAINED HIS HANDCUFFS. OFFENDER WAS TAKEN INTO CUSTODY WITH THE ASSISTANCE OF MULTIPLE UNITS RESPONDING TO 10-1 CALL. VICTIM SUFFERED SWELLING TO RIGHT HAND AND POSSIBLE SPRAINED FINGER AND THUMB AND INFORMED R/O'S THAT HE WOULD SEEK TREATMENT AT A LATER TIME. OFFENDER SUFFERED ABRASIONS, BRUISING AND SWELLING TO FACE AND HEAD AND WAS TRANSPORTED TO NORTHWESTERN HOSPITAL FOR TREATMENT BY DR. MCGEE. DR. MCGEE INFORMED R/O'S THAT OFFENDER WOULD HAVE TO BE ADMITTED TO ENSURE THAT AN OPTHAMOLOGIST WOULD BE ABLE TO EXAMINE HIS LEFT EYE FOR ANY DAMAGE. R/O'S INFORMED OFFENDER OF HIS RIGHT TO HAVE THE CANADIAN CONSULATE NOTIFIED AND OFFENDER CHOSE TO EXERCISE THIS RIGHT, AT WHICH POINT R/O'S NOTIFIED CANADIAN CONSULATE VIA FAX OF OFFENDER'S STATUS IN CUSTODY. DETECTIVE LEWIS # 20260 PROVIDED R/O'S WITH HOLD PAPERS FOR POSSIBLE FELONY AGGRAVATED BATTERY CHARGE. IN CUSTODY: CLARKE, TERENCE - M/2/59. CHARGES:PENDING.
