<p>EVENT #14928 IN SUMMARY: R/O RESPONDED TO O.E.M.C. DISPATCH FOR ASSAULT REPORT. UPON ARRIVAL TO A/2 H/GC/S UNIT, DETECTIVE PATRICK FORD #21029 (VICTIM) RELATED TO R/O THAT WHILE CONDUCTING A LINE-UP, DEMETRIUS POUNCY(OFFENDER ALREADY IN CUSTODY FOR INTIMIDATION CHARGE) BECAME COMBATIVE, AND THEN TOOK A FIGHTING STANCE. THEREAFTER, DET. FORD WHILE ATTEMPTING TO AVOID INJURY PUSHED THE OFFENDER AWAY. DEMETRIUS POUNCY(OFFENDER) THEN FELL AND HIT HIS HEAD CAUSING A SMALL LACERATION TO THE HEAD. OFFENDER WAS TRANSPORTED TO ROSELAND HOSPITAL BY CFD AMBULANCE #51 AND ESCORTED BY BT. 5221, TREATED BY DR. LABRADOR FOR HIS INJURY, AND LISTED IN GOOD CONDITION AT TIME OF THIS REPORT. DET. PATRICK FORD #21029 (VICTIM) WASN'T INJURED, REFUSED MEDICAL ATTENTION, AND WILL NOT SEEK CHARGES AGAINST THE OFFENDER.
