IN SUMMARY ON EVENT #03326 ROBERTO GOMEZ (RO) AND SUSAN YOUNG (RO) WHILE ON ROUTINE PATROL WHEN THEY WERE FLAGGED DOWN BY A HAND WAIVER WHO WAS WALKING N/B ON 2130 S. WESTERN AVE. UPON SPEAKING TO [REDACTED] (VICTIM) RELATED TO R/O'S THAT HE WAS THE VICTIM OF AN ATTEMPT ARMED ROBBERY, VICTIM STATED THAT AN UNK (OFFENDER) APPROACHED HIM ON THE 21ST AND OAKLEY ; HAD DISPLAYED A SMALL SEMI- AUTOMATIC HAND-GUN, AND DEMANDED MONEY AND ASKED IF THE [REDACTED] (VICTIM) WAS A GANG MEMBER, VICTIM DENIED ANY GANG AFFILIATION. VICTIM FURTHER RELATED, THAT THE OFFENDER WENT THROUGH HIS POCKETS, BUT VICTIM STATED THERE WAS NOTHING (MONEY) TO TAKE.
