(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

INCIDENT NARRATIVE

Event #01916. Refer to detective supplemental reports for further details. Crime lab conducted all inventories. In summary, A/O's were called to the scene for a barricaded subject NKA (Carrothers, Darrell). Who resides at [REDACTED] Officers from Cook County Sheriffs/Central Warrants Unit having knowledge of said listed warrant, attempted to serve said warrant and an order of protection. Officers rang the door bell and subject (Carrothers, Darrell) came to a basement window, opened it and stated " Get the fuck away from here". Officer S. Hill made positive identification of the subject as the person wanted on the warrant. The subject then came to the front door and opened it whiled armed with a handgun. Officers tactically retreated to cover positions and called for assistance. The Chicago Police SWAT team was then called out for a barricaded gunman incident. During the standoff with the subject, negotiations were ongoing and after a while the subject stopped talking to negotiators. The decision was made to probe the subject in an effort to get the subject to talk again. CS (tear) gas was deployed/introduced to the rear 2nd floor window and front 2nd floor window. The subject became extremely agitated with this and immediately went to the front door and opened it while armed with a handgun. Subject began to yell "Do that shit again and I'll kill all you Mother Fuckers". Subject then retreated back inside and exited from the rear basement door and approached the garage armed with a handgun. Subject was yelling at the garage "Who the Fuck is in there, I got something for you." Subject puched through the garage window and pointed a handgun at SWAT officers staged inside. Subject retreated back inside to the basement and then re-emerged stilled armed with the gun. Subject was given verbal commands to drop the weapon and after he refused to comply with the verbal directions. Officers were in fear for their lives and opened fire toward the subject. The subject retreated again into the basement stairwell and was repeatedly shouting "You Mother Fuckers gonna come at me like that. I got something for you. I'm going to take one of you's out." Subject refused to drop the gun and presented it toward officers in the garage while he hid below in the basement stairwell. A/O then fearing again for his safety deposited two noise flash diversionary devices which caused the subject to retreat back inside the basement. A/O's then gave more verbal commands for the subject to show his hands. Subject stated he was injured and requested medical attention. A/O's had subject crawl out to the basement stairs where he was taken into custody by A/O's. Subject was then immediately treated by SWAT Medic Villanueva #13319 on scene. And he was then transported to Stroger Hospital by CFD for treatment of his injuries. Subject had an active warrant #CW0028551, Docket: #15DV7601101, Bond: \$5,000, C/W desk contacted Ba #10090 @ 0905 Hrs. Claims no Gang affiliation, clear in TRAP and GIPP. No two degrees of separation. No active Investigative Alerts.
