INCIDENT NARRATIVE

(The facts for probable cause to arrest AND to substantiate the charges include, but are not limited to, the following)

#14750 Above arrested after being observed entering, starting and driving off in listed vehicle which was reported stolen. At approx 4600 W Palmer A/O's turned on all emergency equipment to initiate a traffic stop at which time above refused to stop. Above drove e/b on Palmer, s/b (wrong way) on Kilbourn, w/b on Dickens (fail to stop at stop sign), s/b on Kolmar, e/b on Armitage (fail to stop at sign) through red light at Kostner, n/b on Tripp, e/b north alley of Armitage, n/b east alley of Tripp, e/b Dickens, stop signs at Keeler, Kedvale and Karlov, s/b Keystone (wrong way) w/b north alley of Armitage, s/b on Karlov, stopping at 2001 N Karlov, where he and co-arrestee exited vehicle and fled on foot. Above refused all verbal commands to stop and after having to be tackled still pulled away attempting to defeat the arrest. Above placed into custody, read rights and transported to 025 for processing. At 2320hrs in 025, P.O Deleon again advised offender of his miranda warnings at which time above stated "I stole my uncles' keys today. I knew I was a wanted man, that's why I took off on you guys" A/O's spoke to owner of vehicle who related that someone had taken the keys to his vehicle from his house. The offender is a nephew, but does not live there and hasn't seen him in along time. Victim did not give him permission to enter or operate his vehicle Name check revealed above to have an active Parole Violation warrant and a revoked D/L. Not on gipp/trap
