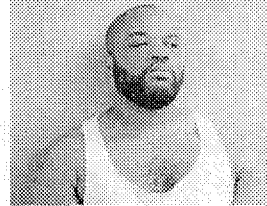

EVENT# 01644 IN SUMMARY: 1162 TEAM ASSISTED BY 1165 TEAM EXECUTED SEARCH WARRANT (15SW5115) AT THE LOCATION OF [REDACTED] AND A TARGET OF KEITH DAVIS(OFFENDER). R/O'S KNOCKED AND ANNOUNCED "POLICE, SEARCH WARRANT" AND WAITED A PREDETERMINED AMOUNT OF TIME AND MADE FORCED ENTRY TO THE MAIN ENTRANCE OF [REDACTED] AND CONTINUED UP STAIRS TO 2ND FLOOR AND AGAIN KNOCKED AND ANNOUNCED "POLICE, SEARCH WARRANT" WAITING A PREDETERMINED AMOUNT OF TIME AND ATTEMPTED TO MAKE FORCED ENTRY. AFTER SEVERAL ATTEMPTS R/O'S OBSERVED KEITH DAVIS(OFFENDER) PUSHING BACK DOOR TOWARDS OFFICERS ATTEMPTING TO BARRICADE SAID DOOR IN AN ATTEMPT TO DENY R/O'S FROM ENTERING THE APARTMENT. R/O'S AFTER SEVERAL MORE ATTEMPTS WERE ABLE TO GET DOOR OPEN AND WERE MET WITH KEITH DAVIS(OFFENDER) IN AN AGGRESSIVE FIGHTING STANCE WITH CLENCHED FIST. R/O'S CONTINUED TO ANNOUNCE OFFICE AND GAVE VERBAL COMMANDS AT WHICH TIME KEITH DAVIS(OFFENDER) SHOVED P.O. NAJM#5088 AND FLAILED CLOSED FISTS AT P.O. NAJM #5088 MAKING KEITH DAVIS(OFFENDER) AN ASSAILANT IN ACCORDANCE WITH THE CHICAGO POLICE DEPT. USE OF FORCE MODEL. P.O. NAJM DELIVERED CLOSED HAND STRIKES TO OFFENDER AND AN EMERGENCY TAKEDOWN.
